DILLON GOES TO BOX FLYNN IN OKLAHOMA

MINNEAPOLIS, June 30.—Chick Evans missed his heart's desire, a national title, today, when he won the twenty-second annual championship of the United States on the links of the Minnikahka club. Making the triumph all the more notable was the fact that his winning score of 286 was the lowest ever made in the national open championship. His ten great rounds of yesterday really won the title, for to-day he did little more than stay in front. Nothing more was asked of him, however, and his victory was as well deserved as it was warmly applauded by the unsuccessful professionals who saw the title that they had been fighting for so long slipping from their grasp to an amateur for the third time in four years.

It was Brown's good golf that beat Carter this afternoon, for the St. Andrews and Hudson River golfer was at his best and played the best round of his career. The match between the two was long, but Brown, who was out in 36, and Carter, who was out in 37, won the match by a margin of one hole. Brown's score of 286 was the lowest ever made in the national open championship. His ten great rounds of yesterday really won the title, for to-day he did little more than stay in front. Nothing more was asked of him, however, and his victory was as well deserved as it was warmly applauded by the unsuccessful professionals who saw the title that they had been fighting for so long slipping from their grasp to an amateur for the third time in four years.
