

GILLETT ISSUES CALL FOR REVOLT ON DRYS

Passage of Beer and Wine Bill and End of Anderson Rule Are Urged.

SEES VICTORY IN HOUSE

Sweet and Drys Equally Confident of Defeating Any Wet Legislation.

Special to THE SUN AND NEW YORK HERALD, March 14.—The fight in the Legislature between the wet and dry forces was brought one step nearer a climax to-day when Col. Ransom H. Gillett, leader of the insurgent veteran Assemblymen, issued an appeal to all members of the Assembly to join the revolt against home dry enforcement.

The wet, including most of the army men, practically all of the Democratic Assemblymen and several New York City Republicans, declare they are confident they can defeat the home dry bill.

Speaker Sweet and the organization Republicans are equally confident they can defeat a beer and light wine bill by keeping it locked up in committee, which is safely dry.

Observers who have been trying to size up the strength and weakness of the opposing forces incline to the belief that the total result of the fight will be the investigation of the Anti-Saloon League and no legislation of any variety.

If the insurgents in the Assembly can force through their beer and light wine bill it is almost a certainty that the Senate will promptly enact a similar measure.

Viewed as Moral Victory. While it is conceded that no State can override a Federal Constitutional amendment, enactment of a moderate drink bill by the Legislature would be regarded by the State as a moral victory.
