

THE NATIONAL COURSE, L. 1.—RACING.

THE SUCCESS OF THE NATIONAL COURSE appears to be established. Many thousands attended the races yesterday, and the appearance of the crowded stands, graced as they were by the presence of many well dressed ladies, presented a beautiful coup d'oeil, while the inner space was thronged with voices and elegant turn-outs of every fashionable description. The utmost order and decorum prevailed throughout the entire proceedings, and the racing itself was highly satisfactory. We regret, however, the utter want of accommodation for the press. They were at first assigned a place in the grandstand, in which there was ample room, and from which a survey of the running could be obtained from beginning to end, which enabled the reporters to give an accurate account of what transpired; but, owing to the captiousness of some would-be exclusives, they were transferred to the jockey club stand, from which they were unable to see the race. An invitation, however, was afterwards extended to them to take seats among the buglers, drummers, fifers, &c., &c., which ridiculous proposition was treated with the contempt it merited.

We noticed among the crowd many old turf-men—the days of Eclipse and Henry— who seemed to glory in the re-establishment of the sports of their youth. Strangers, in numbers, from all parts of the Union, were present. Southerners particularly. Southern horses having attracted them to the course, and they backed their favorites freely. All the horses in yesterday's races came from the South, the North having no representation, although she will have some during the week, and which she must have to insure the stability of this enterprise. Mr. Gibbons, of Madison, New Jersey, is the only Northern gentleman we know of that has made any entry from this section of country. The majority of the horses which ran yesterday were Gloucester's only one of the get of Boston having entered; and as there is much rivalry between the merits of the Gloucester and Boston, we may expect to see something very exciting on the four mile day, should Lexington and Highlander come together, those being the crack specimens of the rival families—in fact, the very best, putting Leconte out of the question for the present. In the great State post-race in New Orleans, it will be remembered that Lexington beat Highlander although afterwards beaten himself by his half brother, Leconte, in the unprecedented time of 7:36. The owner of Lexington had made preparations to take him to Europe, to contend against the celebrities of Great Britain; but after his defeat, which is said not to be owing to the want of speed or bottom, he deemed it due to himself, and the noble animal in his possession, to change his mind, and offered to run Lexington against the best time made in America, or against any horse in the United States, for a large sum. This challenge has since been accepted, and the race, which is against time, will come off between the 1st and 15th of April next. On the other hand, Mr. Boyden, the owner of Highlander, who stands first on the list of the Gloucester's as a four mile horse, is equally sanguine as to the speed and power of his horse, and offers to back him against any other in the world. From this, it will be seen, that the contest will be a very interesting one, and we are sure that many other than by some desiccated content between these famous horses.

CHARLES OF JUDY CAMPBELL TO THE GRAND JURY IN THE UNITED STATES DISTRICT COURT, AT NEW ORLEANS.

On the empanelling of the Grand Jury in the United States District Court yesterday morning, Judge Campbell delivered a strong and special charge on the duties of Grand Jurors, and the principles of the law applicable to the case of the Ouban prisoners. The charge occupied nearly an hour, and was listened to with profound interest. We hope to see it published in full in the *Advertiser*, as it only gives a general idea of the leading doctrines and prevailing tone. After defining with minuteness the duties and obligations of Grand Jurors of the United States, and the public character of the nation against infractions of its treaty stipulations, and its obligations of good faith towards other governments, the Judge proceeded to the immediate occasion for addressing them. He stated that the duties were independent of any information of particular facts, from the court or from the Executive. The court itself is an independent branch of the government, charged with the duty of watching over and maintaining the law, executing justice, and preserving tranquility, and the Grand Jury as part of the court, must proceed to its duty, on its own convictions and belief. The court has no knowledge that a breach of the law has occurred elsewhere, it is a duty that there is an expedition on foot against a friendly power, but there is enough to make it a duty to institute an inquiry. If it should be ascertained that any citizen is engaged in a hostile expedition, it is the duty of the Grand Jury to inquire into it, and if it is truly and fearlessly. Should any expedition depart from this district hereafter, in consequence of their neglect of their duty, the responsibility will rest on the Grand Jury, and not on the Executive or the Judge. The Grand Jury must be vigilant against only military and marauding expeditions, but not against those which are intended to interfere with the public peace and tranquility, and to interfere with the public peace and tranquility, and to interfere with the public peace and tranquility.
