GENERAL FLARE-UP IN HONOR OF THE DAY.

We translate, from the Monsieur Haitien, the following solemn and magnificent description of the ceremony observed on the occasion of the anniversary of that important and ever memorable event, the Declaration of the Independence of Hayti.

According to the prescriptions of the programme of the day, on Sunday the 21st of December, the Excellency the Emperor received the felicitations of the new year from the Legislative Corps, the Consuls of foreign Powers, the different public functionaries, and the representatives of the people of the Colonies and the Protectorate.

The following speeches were successively addressed to His Majesty the Emperor:

By MONSIEUR L'ABBE MOUSSA, CURÉ OF PORT AU PRINCE.

Sire—All the world is agreed on this incontestable principle—that religion sustains authority, and authority religion.

Two inseparable sisters conduct society to its highest state of perfectibility.

Respect, love and attachment to these two powerful ties, the feeble human race has demonstrated to all civilized peoples the secret influence of those two agents of morality or public decline.

Sire, the country is grateful to you for the seal and sanction which your noble spirit has gloriously manifested in difficult circumstances, and we have recognized the finger of God in the protection of your Majesty—a recognition that Providence has bestowed on the Haytian people.

The wish that we form this year, for the glory of your miraculous reign is, that religion shall make a duo with the voice of your Majesty, and that the Father of the Holy Father, Pope Pius IX, recognize your Majesty as his well beloved son, for your noble and generous devotion to the true faith, in Jesus Christ, our divine King.

Long live our Emperor, Faustin the First! Long live the imperial family!

Sire—The Senators present themselves at the commencement of this new year to offer to you their homage, and the wishes that they never cease to form for the preservation of your Majesty's throne, and the prosperity of the Republic to grant them, during long years, the favor of repeating here, "Long live His Majesty the Emperor of Hayti," "Long live the Emperor," "Long live the imperial family."

Sire—We all owe to you the tribute of our good wishes for the happy coincidence which the members of the judicial corps now present themselves to fulfill on a day which recalls so forcibly the glorious souvenirs of the independence of Hayti.

May the memorable events that have founded it serve for the instruction of posterity, and preserve it from the danger of an imperfectly understood liberty, as well as from the evil of an excessive democracy.

Sire, the happiest wish that can be offered to the head of the State is, that he may be always surrounded by the faithful and devoted members of his government, and that the painful and thorny path of the government of men.

If our wishes are fulfilled, your reign will be spotted with desirable and brilliant events of heaven which will be the first sentinels of the palace of your Majesty. She will never cease to be the object of the affection and love of all the people, and will be the object of all human communities propose to themselves, and which will be handed down with blessings to the remotest posterity."

May God preserve your life, and those of Her Majesty, the Empress, and may He deign to shed His blessings on the imperial family.

Such are our wishes, sire—the wishes of every Haytian who lives his country.

By MONSIEUR LE COMTE DE LA NOUVELLE TOULAIN, SECRETARY GENERAL OF THE NAME OF THE ADMINISTRATION OF THE SENATE.

Sire—Your Majesty embracing in your high solicitude all the interests of the State, has seen recently given in your Majesty's dispositions a fresh confirmation of the confidence which you have placed in the devotion and loyalty of the members of the Senate.

Such are our wishes, sire—the wishes of every Haytian who lives his country.

The ladies of the court then offered to their imperial Majesties the congratulations of the new year.

At sunset Fort Alexander announced the file by a salvo of twenty-one guns.

On the following day, the 1st of January, 1855, at three o'clock in the morning, the General was visited, and at sunrise Fort Alexander again fired twenty-one guns.

At six o'clock the Imperial Guard and the troops of the garrison formed in line of battle on the Place Peloton, at the western extremity of which was stationed the imperial corps of artillery. At half-past seven the Legislative Corps and public functionaries assembled at the imperial palace. At forty-five minutes past seven the cortege of His Majesty proceeded to the Place Peloton.

The altar of the country, decorated with banners and streamers of the national colors, was occupied by the Emperor, the Empress, the Imperial Ministers, the Grand Chamberlain, the Grand Marshal, and the President of the Permanent Committee of the Senate.

His Majesty the Emperor delivered the following speech:—

HAYTIENS—This day is the fifty-second anniversary of the independence of Hayti. It is to celebrate it that we are assembled here. Let us swear to maintain forever our nationality, our independence, and our freedom, and let us be in peace with the whole world and with each other. Let us assure our national existence by labor, by industry, and by the long life of our independence.

This address was received with the greatest enthusiasm, increased as it was by the booming of cannon and cries of "Long live the Emperor."

The cortege then repaired to the cathedral church, in the same order in which it had left the palace, viz:—A Plaque of Horse Grenadiers of the Imperial Guard. The band of the Infantry of the Guard. The pupils of the government schools, accompanied by their directors and teachers.

The body of merchants.

The ministerial officers of the imperial court and of the different departments of the State.

The officers of the General staff, and those attached to any corps.

The officers of the different departments of the port.

The officers of health.

The Justice of the Peace and his deputies.

The employees of different administrations and their heads.

Discharge of R. T. Haughey and Others from Arrest for Obtaining Money by False Pretences.

A paragraph appeared in our columns, some days since, announcing the arrest of R. T. Haughey and others, of this city, on a charge of obtaining the property of Mrs. Pattison, of Jersey City, by false and fraudulent pretences. The warrant was issued by His Honor the Mayor, but the examination was forthwith transferred to the Recorder, and has since proceeded, from time to time, before him. On the afternoon of the 20th inst. the countess of the Recorder directed the discharge of the prisoners upon the testimony adduced by the prosecution; and after a vigorous opposition on the part of the counsel for the prisoners, the Recorder directed to discharge, and did discharge, the defendants, upon their promise not to call upon the court to enter upon their defence. And thus a most lame and impotent conclusion was put upon the case, and the Recorder, in granting the discharge, the Recorder remarked that upon the testimony of Mrs. Pattison herself it appeared that the offence charged had not been committed.
