MEXICO. The Jimenez-Alvarez War—Corona on the Way to Simlaco with his Division.

APACULCO, Mexico, March 29. General Jimenez has arrived at Simlaco for the purpose of driving Alvarez and establishing the authority of Alvarez in that State.

General Corona has marched his division from Guadalupe towards Simlaco. There is no doubt of his ability to put down the rebellion of Alvarez and his reinstating Governor Rubi in possession of the government of that State.

THE NEW DOMINION. The Canadian Fishing Interests and the United States Customs Regulations—The Canadian Financial Budget.

OTTAWA, April 1, 1898. In the House of Commons, Sir John McDonald declared that the government had information of certain changes in the United States customs regulations prejudicial to the Canadian fishing interests.

He declared to state whether the Canadian government intended to impose additional tonnage duty on United States fishing vessels; government had the matter under consideration.

The minister said that the bill introduced on the 25th of February, which was passed on the 27th of June, 1895, was laid before the House. The total of the expenditure will amount to \$7,500,000.

IDAHO. The War Among Rival Miners—They are Dispersed by the United States Marshal.

SAN FRANCISCO, April 3, 1898. Idaho advises to March 30 that a bloody war had broken out between the Ida Elmore and Golden Charlie mining companies. The cause was conflicting claims to mining property.

The United States Marshal had arrived at Silver City with a proclamation commanding the miners to disperse, and notifying them that the whole force of the army would be called on to aid the authorities in suppressing the riot.

Upon the receipt of the proclamation the parties signified their willingness to submit to the authority of the United States.

CUBA. SPECIAL TELEGRAM TO THE HERALD. Changes in the Royal Institute Faculty—Order in Relation to Baptizing Chinese—Incendiarism—Cholera on the Brig Omoia.

HAVANA, April 3, 1898. The professors in the Royal Institute have not been paid for five months. The chairs of philosophy and literature have been removed, and the students in the university course are now obliged to go to Madrid.

Chamamen desiring baptism have to obtain a residence and present a photograph, together with a written petition to that effect. This is a recent order of the bishop, promulgated for the purpose of preventing a second administration of the sacrament to the same person.

It is believed that the recent fires on the plantations, which have been of late extending, are due to incendiarism.

When the cholera made its appearance at Zamamelo one American aboard the brig Omoia died. The vessel has been quarantined.

THE PARAGUAYAN WAR. Storming and Capture of Humaita—Asuncion Deserted.

LISBON, April 3, 1898. The regular mail steamship from Brazil, bringing dates from Rio Janeiro to the 11th ult., arrived at this port late yesterday.

The news from the contending armies on the Parana is important and thrilling. The allied army stormed the redoubt at Humaita, and, after a desperate resistance, succeeded in carrying the work. They captured fifteen large guns and a large quantity of stores and ammunition.

All accounts agree that the garrison fought desperately. At the time the land forces were so engaged the Brazilian fleet, taking advantage of the moment, successfully forced a passage past the land batteries and reached Asuncion. The city, however, had been evacuated by the Paraguayan troops and deserted by its citizens.

FRANCE. View of Specie from the Bank.

PARIS, April 3, 1898. The regular weekly returns of the condition of the Bank of France are published to-day over the signatures of its officers. The returns are less favorable than for a long time past.

There has been a heavy outflow of specie, and the amount on hand this week is more than 17,000,000 francs less than last week.

PENNSYLVANIA. One of the Hanlon Brothers Found to be Insane—He Attempts to Murder Three Boys in Harrisburg, and on Being Arrested Tries to Commit Suicide.

HARRISBURG, Pa., April 3, 1898. Thomas Hanlon, one of the Hanlon brothers, gymnast, was arrested here this morning for drunkenness; but was found to be insane and discharged.

Shortly afterwards he was again arrested for attempting to murder three boys, who were accompanying him, and was placed in the county prison, where, this morning, he made an attempt to commit suicide by throwing his head violently against the bars of his cell.

Six men were required to secure him, when he was bound down and his wounds dressed.

THE PLAINS. The Indian Commission at Omaha—General Sherman Leaves for Washington—Spotted Tail? Awaiting the Commission on the North Platte.

ST. LOUIS, Mo., April 3, 1898. The Indian Peace Commissioners held a short session at Omaha on Wednesday night. General Sherman left for Washington yesterday, and General Miles will take his place on the Commission.
