The Clark Divorce Case.

Before Judge Garvin. Marvin B. Clark vs. Sarah Esther Clark.—This divorce case, which has been so frequently before the courts under various phases, came up yesterday on a motion for alimony, and on an application by the defendant for the custody of the child born to the parties which is at present in charge of the plaintiff. The old story of counter charge of infidelity was rehearsed, as on previous occasions, the husband claiming that the wife is not a proper person to have the care of her child. Decision rendered.
