

THE COURTS.

A Marine Court Officer After His Pay—Decisions—Trials, Pleas and Sentences in the General Sessions.

In the United States District Court, before Judge Hatcher, the case of Henry P. Devos, assigned a bankrupt of Martin Murphy by William P. Tyson, was brought on yesterday for trial.

attempt at robbery. He was sent to the State Prison for the term of seven years.

James McKean, John Burns, who, on the 25th of March, stole a travelling bag, containing underclothing, belonging to James Feely, pleaded guilty to petty larceny, and were each sent to the Penitentiary for six months.

A Female Burglar Sent to Sing Sing. Mary Williams was tried and convicted of burglary in the first degree, the proof for the prosecution being that on the night of the 5th of March the sailors' boarding house of Rudolph Loehner, No. 344 Water street, was broken into, and a miniature watch and some sailors' clothing taken by the woman and a man who escaped. The property belonging to the man was found in the hands of complainants handed over to an officer.

Burglars Plead Guilty. George J. Quinn, who on the 20th of March entered the apartments of Jacob Schlemmer and stole about \$40 worth of jewelry belonging to Mrs. Schlemmer, pleaded guilty to an attempt at burglary in the third degree. A similar plea was accepted from John McEade, who was charged with breaking into a liquor store occupied by Michael Fitzpatrick, No. 345 East Thirty-fourth street, on the 20th of March. He stole a revolver and worth of liquors and cigars. These prisoners were each sent to the Penitentiary for two years and six months.

Frederick Marville and George Miller pleaded guilty to an attempt at burglary in the third degree, the indictment alleging that on the night of the 27th of March the prisoners attempted to enter the cutlery store of Hall & Smith, No. 80 Beads street. They were sentenced to the State Prison at hard labor for two years and six months. An Assault. Edward Smith was convicted of assaulting Maria Huntington on the 11th of February. Being a youth of unexceptionably good character previous to this charge, he was sentenced him to the City Prison for twenty days.

Assault by a Boy. Before Judge Bixby. James Goff, of No. 18 West street, charged Andrew McGeehan, sixteen years old, with discharging a loaded pistol at him. The boy, who is a good looking fellow, and is in the hands of the Court, said that Goff had been in the habit of threatening to beat him whenever he met him in the street, and that he merely fired the pistol to frighten Goff. Andrew was committed in \$500 bail to answer.
