Refusal to Dismiss Complaint in the Black Friday Suit.

How Aldermen Formerly Made Money.

MYSTERIOUS VOTES EXPLAINED.

The trial of the suit of De Witt C. Taylor against Judge Gould and others, popularly known as the Black Friday suit, was resumed yesterday before Judge Barrett, of the Supreme Court.

Immediately upon the opening of the Court Judge Barrett rendered a decision upon the motion made by Gould to dismiss the complaint.

As to the revocation of the authority given by Fisk to Speyer to buy gold, Speyer testified that he thought Fisk was trying to shift the responsibility on to his shoulders, and Judge Barrett holds that the revocation was not direct and decisive, as it ought to be where the rights of third parties are involved.

Regarding the second objection, as to whether there was any contract, there having been no memorandum signed or existing between the parties prior to communication and no mutuality of obligation, Judge Barrett held that it was not necessary to have mutuality of obligation.

It was a sufficient contract at common law if the memorandum was executed at any time prior to communication, and indeed the memorandum of contract was merely evidence of the contract, and not the contract itself.

The objection was therefore untenable. The question to be considered was whether Speyer had exceeded his authority as agent.
