POWERS OF THE HEALTH DEPARTMENT

Unexpected Disposition of a Queer Slander Suit.

The General Term of the Court of Common Pleas has rendered a batch of decisions, among which the following are the most important.—In the case of the Health Department against Mary Flinchney the facts are as follows:—In 1873 the Legislature abolished the Metropolitan Board of Health and created the present Health Department. Under the laws relating to the old Metropolitan Board it was empowered to and did bring actions for a penalty of \$50 against all persons who failed to comply with orders made and it claimed to have been made for sanitary purposes.

The defendant in this case was the owner of property upon which the Board repeatedly ordered her to fill up. These orders she did not obey, and a number of actions for penalties have been brought against her. In each case she was successful, until finally, several months ago, one case, decided in her favor, was reversed at General Term on the ground that the Board had no authority to make its decision upon an erroneous ground.
