

COURT DENOUNCED HYLAN'S DEFENDER

Mayor Cites Justice Greenbaum's Attack on Turner for Seeming Fraud.

CALLS HYLAN "BRAZEN"

Challenges Rival to Tell if He Knows Whither Court Papers Vanished.

Keeping up his vigorous denunciation of John F. Hylan, Tammany's candidate for Mayor, Mayor Mitchell last night made a bitter attack on the Judge for the latter's activities in the Black Diamond Automobile Company, with which Alfred H. Goslin, swindler and jailbird, later became connected, and upon Judge Hylan's appearance as an attorney of record in a number of so-called "strike suits" instituted by men alleged to have been working in the interests of Goslin.

COLER CLAIMS 300 GAIN IN RECOUNT

Bird S. Coler charged that 149 of 160 ballots cast in the Third election district of the Third Assembly district were forged.
