MYSTERY IN ARREST OF RUSSIAN PRINCE

Release Equally Puzzling to Police and Local Federal Authorities.

SUSPECTED BY GERMANS

Freed There Through Efforts of Opera Singer and U. S. Consul.

Agents of the Department of Justice sprang a regular out and out dime novel mystery on New York in the arrest early yesterday morning of Prince Michel de Roudakow of Russia, his detention incommunicado in the East Sixty-seventh street police station and his final spriting away in a taxicab as the first shades of night were creeping on.

Arrested in Hotel Room.

The Prince was arrested about 1:45 o'clock in his room in the Hotel Nassau, 52 East Fifty-ninth street, adjoining the Board of Education Building, and was first taken to the local branch of the police station.

Officers Gave Numbers.

Speaking over the telephone from the pastorate in Brooklyn last night, Mr. Herrlich said:

"I tell you, it is a grand mistake. There is not a more democratic man in America than Roudakow. He is as truly anti-German as I am. Why do you know the man's mind. I know it could not be."

Both Mr. and Mrs. Herrlich said the latter had met Roudakow through a friend, the highly paid German spy, who had been in rather straightened circumstances since the Russian revolution.

They laughed at the idea that he might have been mixed up in a speculative scheme, insisting that he had practically depended on some of his friends here for support pending remittances from Russia.

Mrs. Herrlich said that Mrs. J. Henry Watson, now in a sanitarium in Battle Creek, Mich., is one of several Americans who know the Prince and can vouch for him. To show that he was never trying to make a living at other things and therefore could scarcely be one of the highly paid German spies, Mrs. Herrlich cited a brief checkbook of the Farmers Loan and Trust Company.

She intimated that ill health had compelled him to relinquish the clerical job.

The register of the Nassau shows that Roudakow stopped there on September 27, paying for a day in advance and that on the following day he was on an account. Prior to September 27 he had been at the Pines, Lake Placid, for three months, according to Mrs. Herrlich, and before that had lived in Park eighth street, near Fifth Avenue.

Mrs. Herrlich explained her arrival in this country ahead of Roudakow by saying that the Prince had grown tired of the book passage in Copenhagen and had gone back to Berlin, thence returning to this country via Holland and England.

Registered as Commoner.

The Prince registered at the Nassau as "Mr. A. Roudakow, New York. He was known as Prince Roudakow, however, though the title as used was but a joke. The night clerk at the hotel, illustrating his unpretentiousness, said that the Prince had grown tired of the book passage in Copenhagen and had gone back to Berlin, thence returning to this country via Holland and England.

The clerk also said the Prince had several trunks and that these had been searched at the time of his arrest. His passport, all in different languages, was apparently from the same form, was among the things found on the Prince, a person at the police station. These passports seemed to bear out the German arrest story told by Mrs. Herrlich.

Among the telephone calls made by Roudakow was one to the Sparks Detective Agency, 135 Broadway. No one connected with the agency could be reached yesterday.
