Great Prosperity Due Here Soon, He Predicts, After European Trip.

SEES PERIL IN DRY RULE

The cable has ceased to be ubiquitous, as it utterly failed even to hint that Charles M. Schwab was on his way to his native land by the White Star liner Olympic, which docked last night after a swift trip from Brest.

The steel maker, who gave up his strenuous job of directing the forces of the Emergency Fleet Corporation to take seven weeks vacation and incidentally look over the battlefields of France, said he was just naturally expected to see the ship news reporters when he arrived at quarantine, and he was not disappointed.

Survey of Battlefields.

"I made a survey of all the great battlefields partly in an automobile and partly in a car, which I had with me, and I went through the northern part of France and the German territory occupied by the Allies. I went to Coblenz, Metz and all along the Rhine and back to Paris, the tour filling in three weeks. I looked at the destruction wrought by the Germans and saw how they were able to carry out their operations with our own doughboys had fought. When I saw the field of Chateau Thierry I felt proud that one of our boys was an American.

"I was three days at Brest, and talked with Gen. Butler and Hoeselick and had luncheon in the mess hall, writing in the camp book that I was delighted with the meal and the camp organization. Brest is not a place where things can be done expeditiously, but what has been done reflects credit on the responsible officers. It is not exactly a Fifth Avenue, but Gen. Pershing believes that it is pretty good considering the circumstances.

"I met Gen. Pershing and Premier Clemenceau. The Premier is such an American as he is a Frenchman. When I read the ship's radio telling of the capture of the city of Valenciennes, I felt proud that I was a part of it. I was much impressed with the modicum of the French people. He is the most unassuming man I have ever met. He denied that he was a military genius, but he was a great orchestra player together and following the baton of the leader. He was just an officer and all obeyed him.

MUST GIVE UNIFORMS AT ONCE.

Discharged Officers Warned—Enlisted Men Have Three Months. Police Commissioner Enright held back his "not-at-homes" at headquarters yesterday. There were two and possibly three matters which the Commissioner was very anxious not to discuss. One was the breaking up of the radicals' party at Delmonico's, the night before by Allan A. Ryan, special Deputy Commissioner, and the breaking up of the meeting party by Commissioner Enright himself.

"Did Ryan make this raid without the Commissioner's knowledge, and if so, wasn't it going rather far, even for Ryan?" a reporter asked J. C. Hackett, the Commissioner's secretary.
