Insurance Firm Acquires Lehn & Fink Properties on William Street.
BUMORED PRICE \$700,000
George C. Clark's Fifth Avenue Residence Sold; Valued at \$700,000.

Further evidence of the gradual absorption of the wholesale drug district by insurance interests is given in the deal through which Dwight Hillier, American representative of the Employers Liability Insurance Company of London, secured possession of the Lehn & Fink properties at 118 and 120 William street, running through to John Street.

The old Lehn & Fink properties consist of two eight story and basement fireproof buildings 50 feet wide and 130 feet deep and one fireproof building 350 feet long and 100 feet wide, situated at the corner of William and John streets. They are directly opposite the New York Fire Insurance and Suburban Fire Insurance buildings on the east side of William street, and about eight years ago for the drugists, who still occupy them. The new owners will use considerable of the space in the buildings for their own business, while the remainder, the Dwight & Hillier buildings at 86 and 88 Maiden Lane, were recently purchased by the Federal Reserve Bank as a site for its new home, which is to be located at 125 William street.

Sale of the property adjoining at 122 to 126 William street is also indicated by the fact that the new owners, the Lehn & Fink Realty Corporation with a capital of \$750,000, the directors of the company are C. Eno, T. E. Ely and C. S. Brown. The building is a four and one-half story building, 40 feet wide and 125 feet deep, and is assessed by the city at \$200,000. It has been in the possession of the estate of Thomas B. Gilford since 1915.
