GYPSY SMITH WINS

MISS KARIN TJADER Engagement Announced as Evangelist Returns to Britain.

Gypsy Smith, the fighting Scotch evangelist, has wooed and won Miss Karin M. Tjader, daughter of the late Charles Richard Tjader, author, lecturer and explorer. The romance, which began when the evangelist was conducting a religious conference at the Tjader home in Darien, Conn., became known yesterday just before he sailed for England on the Cunard liner Caronia. He smilingly admitted that he "may have time to be married next May," when he will be actively engaged in evangelistic work in this country.

The evangelist came into the world in a gypsy wagon. He is a young man, and has seen much service at the battle-front both as a secretary for the Y. M. C. A. and as an officer of the Northumbrian Fusiliers. When he came to this country early in the year to lecture under the auspices of the British Y. M. C. A., he had not met the young woman to whom he is now engaged to be married.

Miss Tjader is one of four daughters left by the famous explorer, and a sister of Richard Tjader of 17 Battery place, who during the war did a large business as broker in military supplies. Her mother was Margaret E. Thorne, well known socially in New York, being a daughter of Samuel Thorne and a sister of Oakleigh Thorne. Miss Tjader's father's family came from Karlskrona, Sweden.

The Tjaders live in 914 Fifth avenue, but are spending the summer at their summer home in Darien, where the meeting between the young woman and the evangelist occurred early in June.

Gypsy Smith expects to return to this country in December, when he will conduct a series of meetings in the Central Presbyterian Church, Brooklyn.

SEN. EDGE'S FATHER DIES IN 74TH YEAR

Of Quaker Stock and Never Cared for Public Life.

Special Despatch to THE SUN. ATLANTIC CITY, Aug. 23.—William Edge, father of United States Senator Walter N. Edge, died here to-night in his 74th year. He had been ill for nearly a year, his last seizure coming on Wednesday night as he was preparing to take a water ride. He then lapsed into unconsciousness, from which he never recovered. His wife, Senator Edge and another son, Howard, survive.

Mr. Edge was born in Downingtown, Pa., and was of Quaker ancestry. He came to the Shore forty-two years ago and entered the service of the Pennsylvania Railroad. He was superintendent of the transportation during the Philadelphia Exposition in 1876. "Dad" Edge, as he was affectionately known to hundreds of friends, had no liking for public life but was keenly interested in the career of Senator Edge from the time he entered the Assembly in New Jersey until last year, when he went to the United States Senate in Washington. The funeral will be held in Downingtown at a date to be determined.

MAJOR ALEXANDER BARNIE.

Funeral services will be held this afternoon at 2 o'clock at the Fourteenth and Eighth streets, Brooklyn, for Major Alexander Barnie, who died in his home, 425 Gold street, Thursday, after a brief illness. The Veterans' Association of the regiment will conduct the services and the Rev. George Rittenhouse of the Calvary Baptist Church will officiate. The honorary pall bearers will consist of men who have served in the Civil, the Spanish-American or the recent world war.

Major Barnie was born in Harrow street, Manhattan, June 17, 1838. He

moved to Brooklyn with his parents when 18 years of age. He joined the Fourteenth Regiment when it was organized in 1857 and served with it through the civil war. In 1893 he became connected with the office of the Adjutant-General of the New York State National Guard and retired only a year ago, after twenty-five years service. It was during this service that he was commissioned and rose to the rank of Major.

Major Barnie served two terms as president of the Fourteenth Regiment War Veterans' Association. He was also a charter member of U. S. Grant Post No. 327, G. A. R. He leaves a daughter, Miss Belle Barnie, and three sisters, Mrs. John Patterson, Mrs. Charlotte Newcomb and Miss Isabella Barnie.

HENRY A. REED.

Henry A. Reed, who was operator in the first telegraph office opened on the Harlem Railroad in 1849, died at the age of 90 yesterday in his home, 28 North Ninth street, Newark. He was overcome by the heat on the Fourth of July and had been ill ever since. Mr. Reed was president of the Bishop Gutt Percha Company of New York. When he was 18 years old Mr. Reed took up what was then the new science of electricity and was one of the earliest telegraph operators in this section of the country. He was an organizer of the Electric Club and of the Electric Trade Society of New York and with Mrs. Reed was one of the charter members of the Fifth Avenue Presbyterian Church. He married Miss Alice Amelia Boardman, who survives him, and they celebrated their sixtieth anniversary last May. Three sons and a daughter also survive.

N. WILLARD CURTIS.

N. Willard Curtis, president of the East New York Savings Bank and formerly in the lumber business in Brooklyn, died while bathing yesterday in front of his summer home in Beach 141st street, Belle Harbor, L. I. The

shock he experienced at suddenly finding himself out beyond his depth in believed by physicians to have brought about a stroke of apoplexy which caused his death. Dr. Aagner was called from the Rockaway Beach Hospital after Mr. Curtis's body had been brought ashore by Joseph Frank of 7 Beach 140th street, but there was nothing the physician could do.

Mr. Curtis was 53 years old and his town house was at 151 Arlington street, Brooklyn. He is survived by his wife and a daughter, Mrs. Beryl Curtis Ward.

Mrs. Keturah Palmer, 57, wife of Henry P. Palmer, died last night in her home on East Second street, Plainfield, N. J. She was born at Jamaica, L. I., and had lived in Plainfield thirty years. THE REV. CHARLES F. BEATTIE.

Newport, Aug. 23.—The Rev. Charles Frederick Beattie, rector of St. John's Episcopal Church here for twenty-two years, died to-day. He was six feet four inches in height and was frequently called the "Biggest Churchman" in Rhode Island.
