Blanton, who became angered at the refusal of the House to adopt an amendment he offered to another bill.

It is said a request has been forwarded to the State Department at Washington for Correll's wife and son come from the United States to Tampico to identify the prisoners.

OMSK IS NOT EVACUATED.
Hospitals Are Removed Purely as a Precaution.

WASHINGTON, Sept. 5.—Information from the Russian Embassy to-day from Omsk indicates that reports regarding the evacuation of that capital of the Kolchak Government are without foundation.

With the battle lines gradually advancing and with refugees swarming into the city, the cablegrams to the removal of hospitals and similar establishments. Pressure of the Bolsheviks is said to be confined to the despatches, and the Bolsheviks in Siberia have mobilized to repulse them.

DIFFER OVER MERIT OF PACKERS' WORK
Senate Witnesses Assail Plan for Decentralization.

WASHINGTON, Sept. 5.—Arguments that decentralization of the packing industry would cheapen the food supply presented to the Senate Agricultural Committee to-day by Mrs. Florence Kelley, secretary of the National Consumers' League, but retail dealers appearing to oppose the Kenyon and Lincoln licensing bills disagreed with this view.

"Carrying cattle long distances in freight cars," said Mrs. Kelley, "and carrying food supplies further in expensive food equipment is not the way to cheapen the food supply."

The packers, she said, had centralized the food supply and the consumers were paying more because the former used sources were no longer dependent upon to feed Eastern populations.

BRITAIN FIGHTS U. S. PACKERS.
Draconic Measures Planned to Restrict Trade, Says Labor Paper.

LONDON, Sept. 5.—The British Government is taking drastic measures to restrict trade with the United States, the labor organ, the Morning Post, to-day declared. This decision was dictated, according to the newspaper, owing to the "strange and unbusinesslike" attitude of the American packers as exerting on the British provision import trade, and arrangements virtually have been completed for the establishment of a "barrier" between the two countries.

She charges her husband with cruelty and desertion, and asked that he be compelled to pay her the amount of the support of herself and children pending the trial of an action for separation.

AMERICAN MARINES MAY POLICE FIUME
British Also to Replace French, It Is Reported.

PARIS, Sept. 5.—It is understood that the commission of allied and American Generals sent to Fiume to investigate disturbances there, in which French soldiers were killed, has recommended that the police be turned over to American and British police forces, marines forming the American contingent.
