

**Ordinances of the**

**Borough of Lehigh**

REVISED JULY, 1873.

**CHAP. VIII.—Horses, Mules and Swine.**

SECTION 1. That it shall not be lawful for any person or persons to suffer or permit any hogs or swine, horses, mares, geldings, mule or mules, cattle, sheep, goats and geese, to run at large within the Borough of Lehigh, and the owner or owners of any such shall be liable to pay a fine of five dollars for each and every hog or swine, horse, mare, gelding, mule or mules, cattle, sheep, goats and geese, so suffered or permitted to run at large within the said Borough, to be adjudged and recovered with costs, before the burgess or any justice of the peace within the said Borough. One-half to go to the informer, the balance to the use of the Borough.

SEC. 2. That in case any hogs or swine, horses, mare or gelding, mule or mules, cattle, sheep, goats and geese shall be found running at large within the limits of said Borough, it shall be the duty of the high constable or any policeman to impound them, for which service he shall receive one dollar for each and every one so impounded, to be paid by the owner or owners thereof, before recovering their property, and shall forthwith give notice of the fact to the burgess, who, on hearing the circumstances, shall, if he adjudge such hog or swine, horse, mare, gelding, mule or mules, cattle, sheep, goats and geese, to have been running at large within the limits of the said Borough, issue his precept to the high constable to make public sale, after five days' notice, posted up in three conspicuous places in the said Borough, of any such hog or swine, horse, mare or gelding, mule or mules, cattle, sheep, goats and geese, and if the owner or owners shall appear and pay the above fine and costs, before the day of sale, such hog or swine, horse, mare or gelding, mule or mules, cattle, sheep, goats and geese, shall be delivered up, but if not so redeemed, he shall proceed to sell, and after paying said fine and costs, the residue of the purchase money shall be deposited with the Borough Treasurer, for the owner or owners thereof, to be paid over on the fact of ownership being established before the burgess, and so certified by him to the Council.

**CHAP. IX.—Elections.**

SECTION 1. The burgess shall issue his proclamation to the qualified voters of the Borough, at least ten days before the third Friday in March, of each year, and therein state the officers to be voted for at such election.

SEC. 2. That the Town Council, at the meeting at which they organize, and whenever a vacancy may occur, shall elect a Secretary, who shall be duly qualified and enter upon the discharge of his duties, and who shall hold his office until the organization of the new Council, or until his successor shall be duly elected and qualified, unless removed by a vote of two-thirds of the Council.

SEC. 3. The Town Council shall annually, at the first meeting after their organization, and whenever a vacancy may occur, elect a Street Commissioner, Treasurer and a sufficient number of police, who shall enter upon the discharge of their duties after being duly qualified. And the said Council shall also elect a tax collector at the stated meeting in the month of April, and whenever a vacancy may occur, who shall enter upon his duties when the duplicates shall be placed in his possession. The said officer shall hold his office for one year, or until his successor be chosen and duly qualified, unless sooner removed by resolutions of the Council.

**CHAP. X.—Gas and Water Companies.**

SECTION 1. That whenever any company or individual, or either of them, their inspectors or agents, shall dig, or cause to be dug, any trench or trenches in, along or across the streets, roads, lanes, alleys, side-walks, gutters or foot-ways within the Borough, it shall be the duty of the said companies or individuals, or either of them, their inspectors or agents, to keep such place in a condition secure against danger to persons during the time such work may be progressing, and immediately upon the completion of the work to fill up and close such trenches, and also to replace the same in good order at the proper cost and expense of said companies or individuals; provided, that such digging of trenches after being commenced by such individuals, companies or their agents, shall at no time be suspended without unavoidable cause, and in case either of said companies or individuals, or their inspectors or agents, shall neglect or refuse to comply with the provisions contained in this section, such company or agents so neglecting or refusing, shall, for each and every such neglect or refusal, forfeit and pay a fine or penalty of not more than twenty dollars.

**CHAP. XI.—Secretary of Council.**

SECTION 1. That it shall be the duty of the Secretary of the Town Council to keep a written journal of the proceedings of the Council, including the preparing for printing the same and of the ordinances, he shall preserve all documents confided to his care, which shall be open at all times for inspection of any member of the Council, and he shall have the archives of the Borough under his charge, subject to the direction and control of the Council, but no paper shall be withdrawn therefrom by any member without the consent of the Council.

SEC. 2. That the same Secretary shall make out under his hand, and seal of the Borough, certificates to the officers elected by the Council, which shall be delivered to each of the said officers immediately after they are duly qualified.

SEC. 3. That in addition to the duties

imposed, it shall be the duty of the Secretary of the Town Council to act as Secretary of the standing and special committees, keep regular journals of their proceedings and attend to the printing of the same, if required, and give notice to the members of said committees of the meetings thereof.

SEC. 4. That it shall be the duty of the Secretary to keep a true record of all the accounts of the Borough, to receive from the burgess and clerk of the market all moneys collected by them on Borough account; also, to receive all other moneys and to pay the same over to the Treasurer and take his receipt therefor, in order that the Town Council may, at any time, by reference to the books of the Borough, be able to know the condition of the same.

**CHAP. XII.—Awning and Awning Posts.**

SECTION 1. That it shall not be lawful to place, keep or maintain any awning, which shall not extend to the line of the curb-stone of the foot-way or pavement in front of the premises before which such awning shall be placed; nor to place, keep or maintain a side wing or side wings to any awning or awnings, the lower side of which shall not be at least seven feet, six inches above the foot pavement, under the same, nor to place, keep or maintain any device in the same nature thereof on any foot pavement or side-walk, as a sign.

SEC. 2. That any person or persons who shall erect or maintain, any such post or awning, contrary to the provisions contained in this chapter, shall forfeit and pay a fine or penalty of five dollars for each and every day the same is so kept and maintained, after being notified. One-half the fine to go to the informer, and the balance to the Borough.

**CHAP. XIII.—Health.**

SECTION 1. That the burgess and the members of the Council, or a committee of physicians appointed by them, shall constitute a board of health of the Borough, and shall perform all duties in relation thereto.

SEC. 2. That the Council shall make such regulations respecting nuisances, sources of filth, and causes of sickness as the Board of Health may recommend for the government of the internal health of the Borough, and the burgess shall superintend the execution of the laws and regulations in relation to the same.
