The rule purported to recite at length the proceedings of yesterday in court, when Messrs. Steinman and Hensel were arraigned before the bench. It concluded by notifying Mr. Hensel to appear in court next Tuesday at 10 a. m., to show cause, under oath, why he should not answer for contempt, and also to show cause why his name should not be stricken from the list of practising attorneys. He said that the rule in Mr. Steinman's case was precisely the same, saving the change of names.

The respondents directed the attention of the court to the fact that its version of what took place yesterday was not correct. Mr. Hensel asked the court if it had any stenographic or other official report of the

Judge Patterson said he was his own stenographer on this occasion and remembered pretty well what was said. If the answers as he had them were incorrect respondents could give their version in their answer.

Mr. Steinman said that when the court asked respondents if they adopted the sentiments of the article in question they simply replied that they had not said so and did not give any such reply as was stated in the rule.

Interesting Letter from James Buchanan The following letter from James Buchanan, written when he was secretary of state under President Polk, will recall a political episode of thirty-five years ago that will not be without interest in this latter day of civil service reform. FRANK LONG'S TERRIBLE DEATH. Nothing Left but a Mass of Mangled Flesh READING, Pa., Jan. 22.-Frank Long, of this city, brakeman on the Read ing railroad, was instantly killed on the railroad last night between Limerick and Pottstown. He was drawn under the wheels and whirled from side to side until nothing was left but a horribly mangled mass of flesh.
