In the whole transaction the judge has assumed powers which are foreign to his office, and he will find that in this country, editors have rights as well as judges, and as guardians of the public interests, they can criticize the public acts of men who are entrusted with legal powers.

Steinman and Hensel, the people of Lancaster county, whose servant he is, have a right to be informed of it by whoever is courageous enough to give the information.

But even then, how monstrous to permit the person who is individually insulted and offended to determine the quality and quantity of punishment to be meted out to the offender!
