

THE "ESCAPED NUN."

Telling What She Knows About Convent Life.

The announcement that Miss Edith O'Gorman, claiming to be an "Escaped Nun," by which designation she is commonly known to the public, would appear in this city last night, coupled with the further statement that ladies would be admitted to her lecture gratuitously, "but not to front seats," had the effect of crowding the lower portion of the opera house with an audience the greater portion of which belonged to the gentler sex.

According to Miss O'Gorman's narrative, which was delivered with great volubility, she scarcely pausing a moment from the time she began until she had finished, she entered the convent of St. Joseph's, at Jersey City, in January, 1863. At that time she was a young girl, an ardent Catholic, filled with all the pure incantations and desires after holy living incident to the period of youth in one who has been piously trained and carefully nurtured in the faith of her church.

Mr. Steckman was thrown out and was badly cut about the head. He was picked up and taken to a house near by, from which he was subsequently removed to his residence, No. 444 West Orange street. Dr. Boyd was sent for and he found that besides several severe scalp wounds Mr. Steckman was suffering from concussion of the brain. Today he is somewhat better, but is still in a critical condition. The horses were caught after they had run for some distance. The buggy was badly broken.

WEATHER INDICATIONS. WASHINGTON, April 9.—For New England, the lake region, the Middle Atlantic states, the upper Mississippi valley and lower Missouri valley, the Tennessee and the Ohio valley, warmer, clear and partly cloudy weather, winds from northwest to southwest and generally lower barometer.

ANOTHER CLERICAL SCANDAL. What Looks Very Much Like an Attempt to Blackmail a Catholic Priest.

CHICAGO, April 9.—A despatch from East Saginaw, Michigan, says that city is excited over the publicity of a scandal involving the good name of Father Vanderborn, pastor of St. Mary's Catholic church for the past fifteen years. Last night he procured a warrant for the arrest of Kate Burke, who for three years had been his housekeeper, for malicious and wilful accusations affecting his character. In January, 1879, she was discharged from Father Vanderborn's service for cause, and since that time she has been vague threats, culminating recently in her going before a notary public and making specific charges against him of undue intimacy with a lady member of his church and herself while his housekeeper. The charges were laid before Bishop Bogert, at Detroit, who summoned Father Vanderborn before him, and on Vanderborn's indignant denial of the charges the bishop advised him to resort to the civil courts for redress and vindication. The woman previous to going before a notary offered to settle for \$2,000.

THAT ALLEGED OUTRAGE. Cadet Whittaker Under Examination.

WASHINGTON, April 9.—Adjutant General Townsend yesterday received a telegram from General Schofield reporting that all the cadets at West Point had disclaimed any knowledge whatever of the attack on Whittaker, the colored cadet, and that a thorough examination has shown that Whittaker received no injuries except two slight cuts, from which he had somewhat freely. Gen. Schofield has appointed a board of inquiry to begin the examination of the case to-day. The military committee of the United States House of Representatives has appointed Representatives Sparks, Johnston and Brown a sub-committee to investigate the alleged outrage upon Whittaker.

WEST POINT, April 9.—The examination in the case of Whittaker commenced at 10:30, a. m. Cadet Whittaker was the first witness examined and is now telling his story. It thus far agrees with his first statement. He will probably be kept on the stand some time.

THE NEW YORK WALK. The Peds Gaily Peggung Away.

NEW YORK, April 9.—Dobler made his 400th mile at 4 a. m. He is walking today without lameness. Hart is dogging Pegram. Howard will fight for third place. Allen is stiff and slow. Williams is gamely at work. The score at 3 o'clock stood as follows:

WASHINGTON. Hayes Sends in a Nomination, vice Sherwood.

WASHINGTON, April 9.—Hayes to-day sent to the Senate the name of W. J. P. White to be census supervisor for the First district of Pennsylvania.

Democratic Senatorial Caucus. The Democratic senators this morning held another caucus on order of business, but after an hour's discussion without definite result adjourned until to-morrow.

PLUNGED OVER A TRESTLE. Serious Railroad Accident on the Bellair.

WHEELING, W. Va., April 9.—The rear car of a train on the Bellair & Southwestern railroad, jumped the track on a trestle eight miles from Bellair, and went over a distance of fifteen feet. Five or six passengers were injured and it is rumored the mail agent was killed.

TILDEN AND HENDRICKS. The Oregon Democracy Boon for the Old Ticket.

PORTLAND, Oregon, April 9.—The Democratic state convention has chosen six delegates to Cincinnati, and though not positively instructed they are for Tilden. A resolution endorsing Tilden and Hendricks was adopted by a vote of six to one.

GRANT'S ROOM. It Gets a Lift at Louisville, Ky.

LOUISVILLE, April 9.—The Republican ward elections were held here yesterday to select delegates to the state convention. Eight out of twelve wards instructed delegates for Grant; two for Sherman.

NECK BROKEN. How Samuel Robinson Met His Death.

LEESBURG, Va., April 9.—Samuel Robinson (colored) was hanged here this morning for murder. His neck was broken.

HONORS TO PARNELL. Receiving the Freedom of the City of Cork.

LONDON, April 9.—Mr. Charles S. Parnell has received the freedom of the city of Cork for his services in behalf of Ireland.

MORE THAN 100 MILES A DAY. Hart Ties Blower Brown's Score as the End of 95 Hours.

The excitement and interest in the six day race in Madison Square garden, New York, was much greater yesterday than at any time since the beginning of the contest. At least three thousand spectators remained in the garden through the afternoon and in the evening all the available places were unaccountably jammed at an early hour.

Never before has so close a struggle by two men occurred, day after day, as that which has now gone on for nearly a week between Hart and Dobler.

Hart passed Blower Brown's great London score for the first time yesterday at 5 p. m. He was 110 yards ahead of B. B. Hart's score standing 377; Dobler's 376.

By 9 o'clock the throng of spectators was by far greater than at any preceding time during the match. The constant tramping of thousands of uneasy feet, the unceasing murmur of many voices, and the continuous applause by the admirers or partisans of one or another of the rival pedestrians, maintained a steady roar like that of a tremendous cataract.
