To School Teachers

The board of School Examiners for Carroll county will hold meetings for the examination of Teachers, at the following times for the year 1855:—On the 2nd, Wednesday of every month throughout the year, and also on the 4th Wednesday of April, May, September and October. The meetings to be held at the Court House in Carrollton.

1. Every applicant must deposit a certificate of good moral character, of late date, and signed by responsible persons.

2. Each applicant must come furnished with two or three copies of ruled paper; also with pen and ink; and with McGuffey's Fifth Reader.

3. Each applicant will be required to furnish a specimen of penmanship, skill in punctuation, and the use of capital letters, written in the presence of the Board.

4. To each applicant will be submitted a list of questions on Arithmetic, English Grammar, and Geography, to be answered in writing.

5. No applicant will be regarded as qualified to teach, unless entitled to a certificate, who does not correctly answer one half of the questions submitted in each branch.

6. Certificates will not be issued on the day of examination, but, to be retained by mail or otherwise as soon as practicable.

7. Applicants coming in after the class is formed and the examination has commenced will be expected to wait until the next regular day of examination.

8. No certificate will be granted to any person who is known to the Board to be habituated to the use of profane language, to be intemperate, or dishonest.
