SCRIBER for September contains eight pages of illustrations accompanying eight papers, as follows: 1st, 'The Immigrant's Progress from the village in the old world to the prairie farm in the new'—by W. E. Ridding, with some remarkable wood-cuts; 2nd, 'This Fab,' a historical and descriptive paper by Maurice Mauris; 3rd, 'The Land of the Arabian Nights' by Wm. Perry Fogg, including an interview with the present Turkish Minister of War, formerly Pasha of Bagdad; 4th, 'Old Streets and Houses of England,' with anecdotes, by an anonymous writer; 5th, 'An Island of the Sea,' being Fort George Island, Florida, which is described by Julia B. Dodge with enthusiasm, and is illustrated by Thomas Moran; 6th, a practical paper on 'Wells and Cisterns as a Source of late supply,' showing how they can be protected against fouling; 7th, Mrs. Herrick's studies of 'Microscopical Corals'; and 8th, Dr. Holland's 'Nicholas Minturn,' which will come to an end next month.

The other fiction of the number consists of a seasonal story, 'Hooking Water-Melons,' by Edward Bellamy; the second part of 'His Inheritance,' the new novel by Miss Traford; and another story by Mrs. Burnett, author of 'That Lass o' Lowrie's,' entitled 'Loducky,' with North Carolina scenery and dialect. This will probably be the last of short stories by Mrs. Burnett for some time, as she is engaged upon another serial for Scribner.

Other papers in this number are 'A Russian Funeral,' by Eugene Schuyler; 'Hints on the Use and Care of the Eyes,' by Dr. Burnett, the oculist; and a paper on 'College Instruction,' by Charles F. Thwing, who gives some interesting comparisons of instructions in leading American colleges.

The poetry by Richard Henry Stoddard (a catch entitled 'At Merry Mount') Clarence Cook, Mrs. Piatt, Mary Anne De Vere, Mrs. E. C. Kinney and others.

In his department, Dr. Holland abandons topics of the times for 'Summer Dreams,' 'The Old Cabinet' prints a letter about 'Art and the Public,' and comments upon it, and has a poem entitled 'Great Maturio in an Army Gay.' A special feature of the 'Home and Society' department is Maurice Thompson's reply in general to the host of letters he has had about his paper on 'Bow-Shooting' in the July Scribner.

The publishers say that the demand for this number is so great that the article has almost exhausted the edition. Mr. Thompson's present article tells how to make bows, arrows and bowstrings, and also how to shoot, with miscellaneous suggestions to archery clubs. There is also a poem on moral furniture entitled 'Guest and Guest-Room,' and notes on 'The Poor-House and Hospital Visiting.' The other departments have the usual variety.

Str. NICHOLAS for September is brimful of youthfulness and life, and starts the youngsters off with a bound into the new school year.

The frontispiece is a wonder of spirited execution; and the first article, 'Young Folks Fun in Central Park,' from the pen of Mr. Charles Barnard, with pictures by Kelly, sustains and adds to its exhilarating effect. George McDonald follows with the first half of a charming story of Scottish shepherd life, begun by its characteristic touches, and flashes of insight and carrying an admirable lesson. The little poem, 'A Buttercup,' has a cheery heartiness about it that corresponds with the sunny hue of its subject. Mr. Howard Pyle, in both the text and silhouette illustrations of 'Drummer Frit and His Exploits' puts his youngsters to a rare and jolly feast of extravagant adventure; and Joel Stacy comes forward with some funny verses explaining a picture of the 'Fair Minded Men who Walked to Donaham.' Olive Thorne has a capital sketch of child life in the little paper entitled 'Robbie Talks'; and Mr. Wm. M. F. Round introduces a lively and well illustrated account of the reception of 'An American Circus in Brittany.'

Professor Proctor with the aid of diagrams and maps, tells the secret of the 'Dipper' and the appearance of the stars for the month; Ina Carol has a brief but pleasant article on 'Thistle-Puffs,' which is more than a jolly feast of autumn woods under the name of 'Eanachy,' frisks about and travels long stationery journeys, as related by Mr. Lathrop; and Mr. Frank B. Stockton delightfully combines amusement and shrewd counsel in a life-like account of 'How I went a-Drumming.'

The installment of 'His Own Master,' Mr. Trowbridge's serial story, is marked by rapidly deepening interest. Paul Fort, in 'Peter's Rabbit-Hunt,' gives a humorous view of some Russian peasant schools; and the well-beloved 'Little Schoolma'am' has a comical sketch about school-uncleanness, giving several of the children's letters to herself upon the subject, and much sound practical advice.

The very little folks are provided with their share of delights and the departments 'Jack-in-the-Pulpit,' 'Young Contributors,' and 'Letter-Box,' are unusually bright, varied and interesting.
