REVOLUTION. The second session of the bill passed by the House of Representatives in regard to the Supreme Court, is in these words: "SEC. 2. And be it further enacted, That no case pending before the Supreme Court of the United States which involves the action or effect of any law of the United States shall be decided adversely to the validity of such law without the concurrence of two-thirds of the members of said court in the decision upon the several points in which such law is in question."

But with regard to the appellate jurisdiction, it is to be actually exercised in certain cases, if the Supreme Court shall find that the law is unconstitutional. They shall give judgment for it, if they find it constitutional, and against it, if they find it unconstitutional.
