New York, August 26.—The health authorities are making efforts to suppress and destroy the disorder which has recently broken out among the cattle in the city. Every new drove that arrives is thoroughly inspected, and when any symptom of plague is visible, they are condemned. On Monday eighteen animals, from Missouri, were taken to the cattle yard, on One Hundredth street, near East river, where two of them were subsequently discovered to be suffering from the disease. One of them being unable to stand, and another sick, were destroyed yesterday. The remaining sixteen, which were apparently well, have been quarantined.

A woman was arrested, as a vagrant, in Brooklyn, yesterday, who had twelve girls with her. They denied that she was their mother, and the affair is supposed to be a case of kidnapping. A street stabling affair occurred on Atlantic street, Brooklyn, on Monday night, in which Thomas Cunningham, a young man, was stabbed by a German named Bondelst. The wounded man died yesterday and Bondelst was arrested. He confessed the stabbing of the deceased, but claimed that it was done in self-defense, which statement was corroborated by those who saw the occurrence.

Worcester, Mass., August 26.—A lad named Gibson, sixteen years old, belonging in Bain, was drowned in a pond this afternoon. He was riding a horse, while attempting to step from one boat to another.
