POSTAGE.

FREE DELIVERY. Free delivery of Letters by Carriers at the residence of owners may be secured by observing the following Rules:

1. Direct letters plainly to the street and number, as well as the Postoffice and State.

2. Head letters with the name of the writer's Postoffice and State, Street and Number, without interfering with the writing.

3. Letters sent to strangers or transient visitors, or to persons in the city, whose special address may be unknown, should be marked on the lower left hand corner with the word "Transient."

4. Place the postage stamp on the upper right hand corner, and leave space between the stamp and direction for post marking, without interfering with the writing.

5. A request for the return of a letter to the writer, if unclaimed within thirty days or written or printed, with the writer's name, Postoffice and State across the left hand side of the envelope, on the face side, will be complied with. Letters bearing such endorsements will be returned to the writer, free of postage.

Parties using reading boxes, or receiving letters through the general delivery, can receive their mails at their residences or places of business, regularly and without risk, by the Carrier system of Free Delivery. An order to this effect left at the Chief Clerk's desk will secure immediate attention.

The advantage of the Free Delivery system cannot be too highly estimated. It is more regular, more secure, and more convenient than the box system. Many letters pass through the mails, reach this city, and are deposited in the boxes safely, but because of a divided responsibility, fail to reach the firm or individual to whom they are addressed.

The Carriers are all sworn to a faithful performance of service, and are under heavy bonds for an honest discharge of duty. They are not responsible for a safe delivery of letters through responsible carriers, a great evil would be corrected, and many losses now occurring prevented.

Letters may be carried to the Postoffice and registered. If money is to be remitted, a Postal Money Order should be obtained from the Postoffice, where there is no money order office, then the letter should be registered. Money should never be enclosed in an ordinary letter.

MONEY ORDERS. Absolute safety in sending money by mail is secured by obtaining a Money Order, on a Money Order Office, for which the fee is:

There are 185 Money Order Offices now in operation in the principal cities and towns, and a list of the same may be seen at the Postoffice and Stations.

Only U. S. Treasury or National Bank Notes received as payment.

REGISTERED LETTERS. Letters may be registered for any part of the United States, Island of Jamaica, Canada, Great Britain, Ireland, Germany and the German-Austrian Postal Union, embracing the British, French, Prussian, Austrian, Sardinian, and Italian States, by paying postage in full, and a registration fee for--

United States, Island of Jamaica, 10 cents Canada, Germany and German-Austrian Postal Union, 5 cents

POSTAGE ON LETTERS. Letters for the Mails in the United States must be prepaid three cents the half ounce or single rate.

Letters must be prepaid two cents half ounce or single rate.

Unpaid letters are sent directly to the Postoffice in Washington. Letters weighing over half an ounce, and prepaid a single rate, are forwarded, and the balance collected on delivery. Stamps cannot be used for pre-paying postage.

FORWARDING LETTERS FREE. The law provides that "prepaid and free letters shall be forwarded, at the request of the party addressed, from one Postoffice to another, in (subject additional postage.)" A letter which has been delivered by the Postoffice to an authorized person, and by him re-forwarded to another Postoffice, cannot be re-forwarded to its new address without the payment of postage.

Drop letters (not to be forwarded), but they are not to be forwarded with letter postage--three cents for each half ounce or fraction thereof. The provisions of this act do not apply to letters which are not prepaid.

Neither paid or unpaid foreign letters can be forwarded free.
