BISHOP QUINTARD.

The article on the "Real Presence" Criticized and Contradicted in Some of its Particulars. Defense of the Bishop of Tennessee—The Appeal as a "Catholic" Organ, Etc.

DEFENSE OF THE BISHOP OF TENNESSEE.

ENTIRE APPEAL—In your issue of yesterday appears an article which you copy from the New York Independent, and which professes to be a condensation of the American correspondence of the London Church Times. In that article the Bishop of Tennessee is represented as having been present and assisting in services which were conducted in St. Ignace church, of which Rev. Dr. Ewer is rector. Of course any other Episcopal priest or deacon in good standing would have the right to officiate at such a service, whether such church be "Catholic" or "Protestant." (I beg pardon for the use of terms which mean nothing, and which, as usual, are the creation of newspaper reporters.) That the reporter of the article in question should have seen fit to speak of the Bishop of Tennessee in connection with the Bishop of the matter of that, anyhow else, it was just a blunder, such as are made by the London Church Times when they are not a celebration of the holy communion. In the matter of prayers for the living, as participating in these services, it is impossible that any such prayer was used which is not in our authorized prayer-book. Our canon law expressly forbids the use of unapproved prayers in public worship, and any prayer not written in the book, and not specially authorized by the ecclesiastical authority, are in the meaning of the canon, unapproved. It is impossible that any such unapproved prayer could have been used by the Bishop of Tennessee, or by either Mr. Griffin or Mr. Ewer. But, Messrs. Editors, I should not have thought it necessary to trouble you with this paper if you had been pleased to do more than copy what appeared to be an item of news, or if, in your conduct, you had not seemed to go on your way to work injury to the Episcopal church in the diocese of Tennessee, and to the translation of the doctrine of the "real presence" is the same as, or even similar to, the doctrine of transubstantiation, which is not altogether unavailing or unexpected.
