'SEER' DRAWS \$25 FINE FOR SWINDLING WOMEN

Allentown Fortune Teller's Lucrative Business Ends With Plea of Guilty

ALLENTOWN, Pa., Oct. 5. After getting a great lambasting from a number of witnesses whom he had humiliated, Isaac Herzog, a fortune-teller on trial in Criminal Court today, changed his plea to guilty.

Herzog lives in Nazareth, but came weekly to sit in an office and receive customers, many of whom were girls whose sweethearts had lited them, and old women who believe in ghosts, witches, charms and incantations. He told one girl to throw salt over her shoulder while sitting before the fire to bring her lover back from Detroit, and in the last three years he obtained \$54 from Mrs. Mary Brong, who frequently consulted him in regard to catching a thief who stole her stove. Herzog made her believe the thief would come into her yard in the shape of a snake, which she should kill, but no snake ever came creeping along.

Judge Groman fined him \$25 and imposed a sentence of six months, suspended during good behavior.
