with her foot and told him she would "see him in hell" before he could drink.

Number of Dead May Not Be Known

In the wounded list there were sixteen in the Herrin Hospital, three reported in the Carbondale Hospital and a number of others on a sinking mine—believed to be lying in their homes.

There was little question that the exact number of dead never will be known. No one seemed inclined to drag the pond where bodies were reported thrown, and no searching parties have been organized to seek bodies in the woods.

The Hargrave Secret Service, of Chicago, which had thirty operatives on guard when the mine was stormed, has accounted for but four. One of these, Sidney J. May, is known to have been mortally wounded. Three were believed to have escaped. It was said, while the remaining twenty-six were missing.

All request whether from miners or from strike-breakers or mine operators, agree that the victims were shot down in cold blood after they had put up the white flag and surrendered themselves, and their arms to the attacking forces. Many persons in the county uphold the slaughter as a rightful act of judgment. Citizens are laughing on street corners tonight and today laughed and joked over the affair and proudly boasted that "some of these days people will realize that it doesn't pay to try to break a strike in Williamson county."

In the Morgue, women and children, as they passed through, commented on the necessity of the shooters who brought down the victims.

Men who openly boast that they were in the attacking party related with apparent pride the stories of what in the past few days had happened. One story of the attack on C. K. McDowell, strike-breaker's superintendent, was related by many. McDowell, with only one leg was being fired with bullets, according to persons who say they were eye-witnesses.

He refused to march with the other men who were tied together and told to run down the road between lines of attackers, who poured buckshot, rifle and pistol bullets into them as they fled, saying that he'd just as well die where he was. He died where he was said to have made this statement.

Mine Safe Looted

The mine safe was looted and one man, with some \$1500 in bills, stood with a semi-circle of men around him and dealt out the bills like cards, according to the correspondent. A man who was wounded almost to death, kicked around in the searching line in dusty roads, rabbits by snoring the men who were one catching him accidentally between two fires. Surrounded by a medley of men, he saw a knife plunged into the throat of his mother, in the name of your mother, in the name of our God, give us water, only to receive in reply and those such as "Where you're going you won't see water," as a reply.

Mothers carried babies into the trenches and up to the firing line. One mother, carrying a baby, said: "Take care of what your papa did, kid."

Young matrons and girls encouraged their men in the slaying of captive mine operators.

"Let's make sons of them," one of the women suggested as six men, banded together with a rope, were shot down with one volley.

An examination showing that one of the six still breathed, an executioner, with a ready knife, concluded what the bullets had left unfinished.

One of the four men found under a tree in Harrison woods, where the body of a fifth was suspended from a branch, offered a gold watch and \$25 to his tormentors when he saw all was over for him.

"You're a good scout," taunted one of his tormentors, "make a run for it."

The fellow was shot down by the man who saved at him.

A few women ventured to take today's pictures. The cameras were trampled under foot and the women were roughly handled.

Correspondent watched a man walk to the bedside of a dying man and breathe his last. Through it all, although the fight area was traversed a dozen times, there was not a word heard of sympathy for the victim. The sentiment seemed to be that strike-breakers deserved slaughter and that those who received it.

Two of the dead could be positively identified. Most of them had been shot in the morning, yesterday, they were undisturbed last night. Scores watched the processes all through the night, making unprintable remarks about the bodies.

Statements by Wounded

The substance of the statements by the wounded who were among the best regarded was that not a mine worker was injured during the fighting, but that the numerous killed were shot down in cold blood after they had surrendered themselves and their arms. There was no mention from the union miners to consent to those claims.

Joseph O'Rourke, Chicago, miner, said that at the mine, gave the most vivid account of the fight. His story was related as he lay in pain from a bullet through his chest.

"I was shot down here by the Herrin Coal-mining Company, of Carbondale, and I have no way of knowing how many were killed. I don't know how many were for attacking us, for we were unknowingly being used as snipers to keep them from their jobs. We were given hats with our names on and a machine gun was set up at one corner of the mine. Guards were with us all of the time, and most of the guards were night fellows sent in by Chicago detective agencies. I understand the miners sent us warnings to leave the town or we would be run out. We never got them, perhaps the bosses did.

"When we saw the miners approaching yesterday afternoon, we did not know what to do. The guards prepared for fight, most of us workers wanted to surrender. I understand the miners sent us warnings to leave the town or we would be run out. We never got them, perhaps the bosses did.

Coronado Ruling Opens Way to Herrin Mine to Sue

Chicago, June 23.—For the first time since its promulgation, the recent decision of the United States Supreme Court, delivered by Chief Justice Taft, holding that organized labor unions are liable for damages attributable to them, may be invoked in the case of the mine war at Herrin, Ill. That was given yesterday as the opinion of several coal-mine operators.

That double action may result is the general opinion. First, heirs of men employed in the Southern Illinois Coal Company's strip mine, where the rioting took place, may sue to collect damages from the mine owners under the Riot Act; second, owners of the mine property may invoke the recent Supreme Court decision and bring action against the United Mine Workers of Illinois, for damages caused to the property, if any such has resulted from the rioting.
