The scope of work contemplated is the furnishing of machinery, materials, labor, plant and equipment necessary for the construction of the entire irrigation and drainage plant, including pumping machinery, electrical equipment, pump houses, concrete work, pipe lines, flumes, bridges, earth work and structures, and everything else that may be necessary to complete the plant ready for operation.
