


A. J. FOUSEK, Candidate for Mayor.




W. P. WREN, Candidate for City Treasurer.

FAMOUS FRUIT FARM IN FLATHEAD VALLEY GOES TO NEW OWNERS

Former State Horticulturist Sells Rocky Bar Farm to Gallatin County Men.

Kalispell, April 2.—J. C. Wood, pioneer fruit grower of the Flathead valley, and more recently state horticulturist in Montana, has disposed of his famous Rocky Bar fruit on the east shore of Flathead lake to Bennis Brothers of Bozeman, for a consideration said to be \$15,000. Mr. Wood filed on this place as a homestead in 1891 and it was then a dense wilderness and covered with timber. He believed the section would be ideal for fruit raising and when he had cleared the land put out 800 apple trees. These were replaced with other varieties which were found to do better in this section, and in all he planted 4000 trees before finally reducing his orchard to three varieties: McIntosh, Red, Rome Beauty and Wealthy. Mr. Wood exhibited apples at the San Francisco exposition in 1916, at the National Pomological exposition at Washington, D. C. in 1912 and at numerous fairs in other sections and won scores of cups and medals. There are now 50 acres in fruit, including apples, plums, cherries and peaches, and a frost proof packing house and other modern equipment have been built on the ranch.

GREEKS ROUTED; LOSSES HEAVY

Constantinople, April 2.—(By The Associated Press.)—Further confirmation has been received here of the reports that the Greeks have suffered a severe setback at Eski-Shehr and also that they are unable at present to continue their advance.

The Greek official communique says that the Greek army is repulsing nationalist attacks. The Turkish communique says: "We have won a complete victory. The Greek losses are heavy."

London, April 2.—Heavy fighting is continuing around the city of Eski-Shehr, Asia Minor, according to a Reuters message from Smyrna, with the Turks holding up the Greek advance. The total Greek casualties are reported to be more than 7,000 and the Greek medical service is declared to have broken down.

Angora Asiatic Turkey, April 1.—Greek teachers in the American college at Marivan, about 110 miles northeast of Angora, have been court-martialed by the Turkish nationalists.

PHONE USERS STRIKE
Omaha, April 2.—The up in telephone traffic at Bloomington, Neb., was virtually complete Saturday, says a dispatch from that town, as a result of a subscribers' "strike" against the use of telephones. The "strike" was called Friday because of an increase in rates from \$1.25 to \$1.50 per month granted the company by the state railway commission.

Chicago, April 2.—Maj. Gen. Leonard Wood left for Seattle, Wash. Saturday night where he will embark for the Philippine Islands.

PRINTING EMPLOYERS SPLIT.
Chicago, April 2.—The international joint conference council of printing employers and employees Friday night adjourned to meet in New York June 27, without reaching an agreement on the 44 hour week advocated by the employees.

BRICKLAYERS CUT WAGE.
Milwaukee, April 2.—Milwaukee bricklayers and masons Saturday agreed to a cut in wages of approximately 20 per cent, the hourly rate on and after Monday to be \$1 instead of \$1.25.

HARDING AIDS ARMENIA.
Washington, April 2.—President Harding Saturday saved the life of a little Armenian child by accepting a near east relief coupon book representing sufficient funds to provide food and clothing for one child for a year. Mrs. Harding also accepted one of the books.

CUBAN POLITICIAN SLAIN.
Havana, April 2.—Fernandez Quintero, national league candidate for governor of Havana province in the November elections, was shot and almost instantly killed Saturday evening by Ernesto Colledo, liberal candidate from Santa Clara province.

SWINDLER SENTENCED.
Los Angeles, April 2.—Everett A. Hutchings, convicted of swindling J. B. Norris of Decatur, Ill., out of \$51,000 in a fake stock deal, was sentenced from one to ten years in the penitentiary.

BLUE LAWS INVOKED.
Pierre, S. D., April 2.—Enforcement of South Dakota's blue laws which was scheduled to begin tomorrow will be carried out on sole initiative of county attorneys, Attorney General Payne said Saturday.

Sand Coulee, April 2.—Orders have been received at the Anaconda mines at Tracy to close down indefinitely. This will throw 100 or more men out of employment.
