White Sox Stars Help Former Teammates by Testimony They Give

Say Seven Indicted Men Were at Practice During Time Bill Burns Declared Them in Hotel Room.

Chicago, July 28.—The defense in the baseball trial rested its case Thursday night after five Chicago White Sox players had made statements from the witness stand tending to disprove some of the most important points in the state's evidence against their former team mates, charged with conspiring to throw the 1919 world series to Cincinnati.

Eddie Collins, Ray Schalk, Dick Kerr, Roy Wilkinson and Manager William Gleason, of the White Sox, testified at a night session of court that the seven former players on trial were at Rodland's fields, Cincinnati, practicing from 10 a. m. to 12 noon, the day after the 1919 world series game. Bill Burns testified that at these hours that he completed the alleged deals with the defendants where by they were to throw games in 200,000 after each game thrown.

The state will now begin its rebuttal testimony with indications that Judge Friend may order Saturday night sessions in the hope of getting the case to the jury this week or early next week.

Asked Some Questions. Testimony of the players said to have been double-crossed by the men for whom they were testifying was brief, each man being asked the same questions by the defense attorneys, who had subpoenaed them, forcing them to take part in the trial.

Manager Gleason said he left Chicago with his team Monday night, two days before the first game. "We reached Cincinnati about 8 a. m.," said Gleason, "and went to the Hinton hotel. A little before 10 the men went to Rodland field for practice. We got back to the hotel a little before noon."

Gleason said he thought Weaver was at practice, and he was sure Folsch, Risberg, Gandil, Williams, Jackson Cicotte, the other player-defendants, were there. All at Practice. Schalk said he believed all the defendants were at practice as he did not miss any of them. Eddie Collins, Roy Wilkinson and Dick Kerr were sure all were present and Collins said he and Weaver left the park together and went to the races that afternoon.

Schalk then was called as a state witness. "Did you see some of the defendants together in a room the evening of the second game?" asked George Gorman, of the prosecution.

"I did, but I can't remember what room," he replied. Burns had testified as to another meeting that night. All of the players were asked if they had an opinion as to whether the defendants played to the best of their ability, but the state objections to answers were sustained.

Dick Kerr was indignant over being called here for two minutes of testimony.

TWO CLAIM TITLE OF MIDDLEWEIGHTS AFTER OHIO FIGHT

Cleveland Boxing Commission Gives It to Downey, Referee to Wilson.

Cleveland, July 28.—The middleweight boxing championship of the world is in dispute. The round according to the Cleveland boxing commission and sports writers who were at the ringside, the title belongs to Bryan Downey of Cleveland, he having acquired it by a knockout over Johnny Wilson of Boston, in the seventh round of a scheduled 12-round no-decision contest here Wednesday night.

But Jimmy Gardner of Lowell, Mass., former welterweight boxer, who refereed the match, declared Wilson retains the championship because Downey fouled Wilson.

Wilson was knocked down three times in the final round. The round was just one minute and six seconds old when Downey sent Wilson down with a right to the jaw and a left to the chin. Wilson was on his feet when Gardner slowly counted nine. Whether he counted the last and fatal second was disputed. Official Timekeeper Artie Foote, of the boxing commission, said he heard Gardner count the fatal second and that his watch showed Wilson had been down 13 4-5 seconds.

After Wilson regained his feet, Downey hammered him to the floor again and Gardner counted nine as Wilson staggered to his feet.

Downey again showered him with rights and lefts and Martin Killie, Wilson's manager, jumped to the platform and placed his hands on Wilson, who was sagging to the mat for the third time. After counting seven, Gardner stopped the bout, saying Downey had hit Wilson while he was down.

A near riot followed.
