BAR ASSOCIATION CONDUCTING DRIVE TO HELP ORATORS National Contest for Schools Scheduled by Citizenship Bureau. Dallas.—(Correspondence of The Associated Press.)—A national oratorical contest for American law schools will be undertaken by the citizenship bureau of the American Bar association, according to announcement by R. E. L. Sauer of Dallas, chairman of the committee. At least four entrants must participate in a local contest to be held on Lincoln's birthday, February 12. The winners in the local contests will go to a state contest to be held on the evening of Flag day, April 14. Bi-district contests will be held on the evening of Washington's birthday, February 22. The winners in the state contest will then engage in one of the eight district contests to be held on the evening of Memorial day, May 30. These are the tentative plans outlined by Mr. Sauer and Dr. Shurter. "Traveling expense of the contestants will be pro-rated at the state, bi-district and national contests and guaranteed with a specially designed dial representing the American Bar association will be awarded to first and second honor men at the district contests. The first and second place winners in the national contests will be awarded cash prizes of \$1,000 and \$500, respectively. Dr. Shurter declared.

Labor Federation Failure in Japan Osaka, Japan.—(Correspondence of The Associated Press.)—An attempt to form a federation of the labor unions of Japan has ended in failure, owing to the inability of the socialists, who are in control of some of the unions, to agree with the regular unionists, who avoid politics. A conference called here for October 1 ended in a row in which the police took a hand, eventually arresting a number of the socialists. The Nippon Rodo Sodomei, the socialist party, wanted a federation with central control while their opponents, the Kumai Sodomei, wanted local autonomy. On the discussion of the rival resolutions, an outcry arose which threatened to develop into a free fight when the police intervened and were made the targets of bottles and stones, but soon got the upper hand, cleared the hall and took the ring-leaders to jail, whence they later were released. At a meeting of the Nippon Rodo Sodomei, after the failure to form a federation, a protest was entered against "the outrage committed by the members of the Kokusai kai upon members of the Sodomei" at a recent meeting held at Kyoto. Another cause of the lack of strength on the part of the present time is the business depression, many skilled workmen, especially those in the engineering trade at present being out of work.

Journalism Proves Popular in Japan Tokio.—(Correspondence of The Associated Press.)—Newspaper work and teaching would appear to be the choice of Japanese naval officers next to their own calling. Enquiries made by the navy department of officers to be discharged under the naval reduction plan as to what work they would like to take upon leaving the navy showed that journalism and teaching were the favorites.

MODERN INVENTIONS AID REMOTE ALASKA IN WORLD RELATIONS Tractor and Airplane Cut Down Distances; Aid Transportation. Anchorage, Alaska.—(Correspondence of The Associated Press.)—Remote sections of Alaska, weeks and months away from the railroad under the old transportation methods, are being brought closer to the seaports and railroad towns by the airplane and tractor. Two sections of Alaska, the Iditarod and the great Kuskokwim country, reached from here in the winter only after a 15 days' trip with a dog team, can be made in two or three days by airplane. The tractor's part in the revolution of transportation methods comes in hauling ore and coal from the mines to the railroads. The army type caterpillar tractor, dragging from 20 to 50 tons, breaks its own trail over the snow and is rapidly taking the place of the horse in many places. Sections of the far away Alaska peninsula and Alutian islands, with their oil possibilities, are soon to be prospected by airplane for a group of the Anchorage business men. The machine will be of the hydroplane type and will alight in the rivers, bays and lakes for shore work. One orator, C. O. Homontree, is considering establishing a chain of stations in the interior, to which he can carry supplies by the air route. At present the prospectors on the "inside" generally spend their winter months hauling their supplies in over the snow trails. Hamontree's plan is to carry supplies to established posts and thus save the prospectors the heavy task of pulling their food and equipment over the snow. The stations would be on the lakes or rivers so the plane could alight on the water. FIVE-LEGGED CALF Laurel, Mont.—(Correspondence of The Associated Press.)—A five-legged calf, "Quint," as she is appropriately called, born January 3, 1922, on the L. R. Dallas.—(Correspondence of The Associated Press.)—A national oratorical contest for American law schools will be undertaken by the citizenship bureau of the American Bar association, according to announcement by R. E. L. Sauer of Dallas, chairman of the committee. At least four entrants must participate in a local contest to be held on Lincoln's birthday, February 12. "Traveling expense of the contestants will be pro-rated at the state, bi-district and national contests and guaranteed with a specially designed dial representing the American Bar association will be awarded to first and second honor men at the district contests. The first and second place winners in the national contests will be awarded cash prizes of \$1,000 and \$500, respectively. Dr. Shurter declared.

HAITI COFFEE CROP TO BREAK RECORD, BIG PROFITS DUE Roads Crowded With Loads of Berries Destined for Western Europe. St. Marc, Haiti.—(Correspondence of The Associated Press.)—There are indications in plenty here that the coffee crop which is now being picked and shipped will be the largest ever exported from Haiti in all her history. St. Marc is the center of the coffee growing country, and already the roads and trails are pouring in a flood of the aromatic berries that find such high favor in western Europe. Since the export tax on coffee produces a little more than one-third of the government's entire revenue, and the coffee exports average two-thirds of all Haiti's export trade, the importance of this record breaking crop can be appreciated. At the peak of the French regime in Haiti a crop of 74,000,000 pounds was exported to Europe in 1911. Thirty years later it had dwindled to 25,000,000 pounds as a result of neglect and the incessant civil wars following Haiti's independence in 1808. Under Haitian rule it finally climbed in 1880 to 78,000,000 pounds, but the production was again at low ebb when the United States intervened in 1915. Three years later, when American troops had restored order in the island, it reached a total of 80,000,000 pounds; of \$10,500,000 declared value, and that year the crop paid 40 per cent of Haiti's entire revenue. The present crop, however, is destined to exceed all previous French, Haitian and American occupation figures, and the average price to the peasant will be nine cents a pound. Practically all of the coffee goes to Havre for distribution through France, Belgium, Holland, Germany and Austria, where it is used in small lots as a grading coffee. It is worthy of note that practically the new crop will bring to Haiti will go into the pocket of a single American for the coffee industry in Haiti is wholly in the hands of Haitians, a few French, and a small number of men of mixed blood. There is not a single cultivated plantation in Haiti. The berries grow semi-wild from the old French days, requiring no irrigation and receiving practically no care. Coffee experts hold that through the indolence and ignorance of the peasants, fully one-half of the average crop is not picked. With attention to shading and pruning, and with reasonable diligence, the coming bumper crop could certainly be quadrupled, they aver. The coming revision of the Haitian tariff that will materially reduce or eliminate the present export tax of three cents per pound will materially increase the profits of the peasant, and with the extension of the roads and trails made possible by the Haitian loan, coffee prospects are considered very good indeed. While Haitian coffee has not as yet gained a foothold in the United States, its distinctive aroma and strength have outstripped all competition in western Europe. REALTY TRANSFERS.
