Trade is Good

New York, Jan. 26.—R. G. Dun & Co.'s weekly review of trade says: "Rarely has there been more business in cities and in manufacturing districts as practically unchanged prices than during the period since Nov. 1. The trade in pig iron and other metals is unusually active."

New York, Jan. 26.—R. G. Dun & Co.'s weekly review of trade says: "Rarely has there been more business in cities and in manufacturing districts as practically unchanged prices than during the period since Nov. 1. The trade in pig iron and other metals is unusually active."

After a week of quiet conditions, partly due to uncertainty regarding competition among leading iron and steel manufacturers, the market has taken another stride forward. The feature was enormous buying of pig iron at an advance to \$12.35 Pittsburgh, and a similar activity on the raw material removed fear that stocks might be accumulating at future prices, which is a most unusual feature in the iron and steel industry.

It is difficult to find encouraging features in the wool situation. Sales for the week at the chief eastern cities were a million pounds smaller than in the preceding week and in four weeks the aggregate is only 13,775,700 lbs. against 21,564,700 lbs. last year.

Not only is there a moderate decline in speculative operations, but purchases by manufacturers are restricted to requirements for orders of small quantities, and the market has not hardened in sympathy with the better prices obtained at London, while a few sales here reported at a moderate concession.
