Invitations were sent out by telegraph to the governors of all states in the east, middle west and northwest and the mayors of the principal cities in these states to send delegations to the conference, which it is hoped will have sufficient efbring about some settlement of the strike.

The Associated Press was requested to announce that the invitation was meant for the country at large, it being manifestly impossible to telegraph to every

Telegrams were sent to the governors of the following states: Michigan, Ohlo, Indiana, Illinois, Wisconsin, Minnesota. Missouri, Kentucky, Pennsylvania, New Maryland, Iowa, Massachusetts Rhode Island, New Hampshire, Vermont Maine, Connecticut and New Jersey.
