

JOHNSON LED BOTH

He Captured a Majority of Delegates in the Second and Ninth Districts.

Babcock Writes a Letter Attempting to Offset Charges of Enmity to Administration.

Johnson captured a majority of both the second and ninth districts yesterday, but as anticipated, they did not enforce the unit rule.

The presence of insurgent members from Hennepin and anti-administration leaders did not appear to have much influence on the assembled legislators.

The vote at the ninth district caucus was seven for Johnson, five for Babcock, with one missing and claimed for Babcock.

The second district caucus resulted in six pledges for Johnson from among those present, only two holding off.

The Johnson pledge was signed by Nyquist, Norman, Wilder, S. D. Peterson, Schroeder and Jacobson.

DR. BABCOCK'S REPLY It Attempts to Offset Charges of Enmity to Van Sant.

Dr. Babcock replied to L. H. Johnson's invitation for a caucus last evening in a letter which would be humorous were it not for the fact that the minister is so much in earnest.

"I have not been in haste to reply to the proposal for the reason that I deemed it best to give the matter the most careful consideration, and after consulting with my friends and supporters I have reached the following conclusion:

"For myself and friends I can say that we will be perfectly satisfied to let the question go to a vote immediately were it not for the fact that your managers have taken a most unfair advantage of me by representing to the legislature that I am opposed to Governor Van Sant's administration.

"We believe this charge to have been made without sanction of the governor himself, who has been absent from the state and evidently in ignorance of the action of your friends.

"I further believe that were the governor cognizant of the manner in which the case he would immediately repudiate in his official capacity any attempt on the part of the executive to interfere with the legislative department of the state.

"However, since you have coupled the governor's name with your candidacy, I will most willingly consent to have a caucus at any time that the governor himself may designate over his own signature, provided that at the same time he will say that my election as speaker would be a personal or political affront to him.

"I am in receipt of yours of the 24th inst., in which you propose an immediate caucus of the legislature for the purpose of settling the speaker's contest, and in which you urge such a course for the purpose of promoting party harmony and the avoidance of useless bitterness.

"I have not been in haste to reply to the proposal for the reason that I deemed it best to give the matter the most careful consideration, and after consulting with my friends and supporters I have reached the following conclusion:

"For myself and friends I can say that we will be perfectly satisfied to let the question go to a vote immediately were it not for the fact that your managers have taken a most unfair advantage of me by representing to the legislature that I am opposed to Governor Van Sant's administration.

"We believe this charge to have been made without sanction of the governor himself, who has been absent from the state and evidently in ignorance of the action of your friends.
