IT'S HIS PET HOBBY

So Says Warren Manning of Boston Regarding the River Parkway.

Twin Cities Will Have One of the Finest Drives in the World.

"There is no urban or interurban parkway scheme in America that interests me so much as the plans now being executed for a magnificent driveway along the grand ravine of the Mississippi river between Minneapolis and St. Paul."

Warren H. Manning, the celebrated Boston landscape architect, who has had much to do with beautifying Minneapolis parks, so expressed himself this morning, when his attention was called to the steps recently taken by which most of the land for the Minneapolis portion of the drive has been acquired.

"That driveway is my pet park hobby just now," continued Mr. Manning, "and I can scarcely tell you how gratified I am at the great work the present park board has accomplished toward actualizing this connecting link between the two cities. A little later it would have been impossible to have conferred this great benefit upon the community, as private interests and permanent improvements of a different character would have encroached more and more upon the river bank. It is the one thing needed to complete the general outline of Minneapolis' park system and the same applies equally to St. Paul. It means that the river bluffs which have excited the admiration of the continent will be joined in all their natural grandeur, giving these two cities as they gradually solidify one of the finest urban drives in the world. The parkway will have a big commercial value, too, as it will doubtless contribute greatly to the upbuilding of the interurban territory."

Mr. Manning will be in Minneapolis for a week or more, on private land excursions and the Lyndale parkway. He has just returned from the Yellowstone National park, where he was called into consultation with the government's representatives in plans for beautifying the immediate surroundings of the principal points of interest.

"The park itself was so well planned by the Creator from a scenic standpoint, and is such an immense stretch," said he, "that man's pigmy handiwork could work no noticeable change in the general landscape. It is our great national playground, and is becoming such more and more each year."

Mr. Manning expressed regret that the plans for a national park in northern Minnesota should have fallen through, a fact he said, for which future generations would uphold the present. Most progressive states were taking steps to preserve all beauty spots and forests which had not already passed into private hands.

Parden & Co., independent coal operators, that the miners will insist upon the award of the strike commission being carried out to the letter. These two firms, according to members of the board, have suggested to the men that work be continued under existing conditions without regard to the arbitrating. The proposition was rejected at a meeting of the executive board.

It is estimated that the various classes of employees will receive the following sums: Miners, \$25; laborers, \$13; drivers and runners, \$10; door boys and helpers, \$8; other in-plant employees, \$12; outside employees, \$14; engine pickers, \$4; other outside employees, \$12; strikers, \$22; women and pump runners, \$14.
