ROCKEFELLER A HIGHWAYMAN

Chicago Pastor Preaches a Remarkable Sermon in Which He Attacks Money Kings.

New York Sun Special Service. Chicago, Dec. 14.—There is no difference in principle between holding up a nation for \$1,000,000 at the mouth of a pipe line and holding up an individual at the muzzle of a gun for what he has on his person.

YOUNG GIRL'S AWFUL ILLNESS

She Has Been Fever Stricken for Almost Two Years.—Case Is Unique.

Ithaca, N. Y., Dec. 14.—Miss Leona Ireland, who was one of the first victims of the typhoid fever epidemic here a year ago, and who has suffered from the disease ever since, is now improving, and physicians say that there are hopes for her recovery.

She has had a fever constantly since Jan. 29, 1902, her temperature reaching 106 degrees every day for weeks at a time. Her heart has beat 150 times a minute, and again only 20 for hours consecutively.
