ROSSER PULWOOD FREE

Appraisers Admit Canadian Product as Paper Stock.

New York, April 1.—Another pulp decision of interest to paper manufacturers has been handed down by the board of United States general appraisers, which declares that rosser pulpwood is free of duty as paper stock.

Rosser pulpwood is spruce or poplar, cut into logs, with the bark and roughness removed by a mechanical process. This is done in Canada for economy in transportation.

Logs in this condition are ready to go direct into the grinders. The new ruling was secured upon a protest from a Vermont manufacturer.


ST. LOUIS DEFEATS CHICAGO.

WILLIAMS ASKS TRUST INQUIRY

Democrat Leader Demands Information Concerning Merger and Coal Combine.

Washington, April 1.—Representative Williams of Mississippi yesterday introduced two resolutions of inquiry addressed to the department of justice. One requests information as to whether criminal prosecutions have been instituted against the individuals or corporations who were adjudged in the Northern Securities case to be guilty of having violated the laws of the United States, "and to send to the house all papers bearing upon the prosecutions inaugurated or about to be inaugurated in that behalf."
