COUNTY ATTORNEY IS ON THE SPIT

APPLICATION FOR REMOVAL OF CHAIR OF MARSHALL COUNTY.

Testimony Taken at Warren and Arguments to Be Made Before the Governor on May 3—Crooked Work Charged in Connection with the Construction of Ditch No. 1—How the Alleged Facts Came Out.

Special to the Journal. Warren, Minn., April 6.—The application for the removal of County Attorney G. E. Carr came on for hearing to-day before Commissioners George E. Erickson and W. O. Braggman.

Commissioner Erickson seeks the removal of Carr for malfeasance in office because of his connection with the construction of ditch No. 1 in Marshall county. It seems that Thomas Sanderson of Stephen entered a bid for the construction of this ditch, and to enable him to secure the contract he in partnership with Captain A. C. Rhinehart and the other prospective bidders made an arrangement to pay them \$1,700 to keep from bidding or to make their bids purposely higher so that Sanderson would receive the contract. This was done and thereupon Sanderson and Rhinehart told County Attorney Carr as to the manner of obtaining the contract and induced Carr to enter into partnership with them in the construction of the ditch, and to raise the money to pay the prospective bidders. Sanderson, Rhinehart and Carr negotiated a note for \$2,000 at the State bank of Stephen, of which Carr is vice president, to pay the other bidders.

CAMPAIGN ON THE SLOPE OPENS

WESTERN COUNTIES DISPOSED TO GO TO McCUMBER.

Local Contests Which Have Direct Bearing on the Big Battles Yet to Come—Opposition to White Because of Third-Term Precedent—Barnes County's Convention to Be a Crucial Affair.

Special to the Journal. Bismarck, N. D., April 6.—The campaign on the Missouri slope and in the western part of the state is on. With the city elections and the week lines were drawn and indications given of the nature of some of the battles. In Bismarck the city administration, headed by Mayor Register, and the republicans, headed by Judge Winchester, are in the sixth judicial district and other political games to be played later on, furnished a share of interest that made the election more than usually exciting. In two wards of the city, candidates who stood for re-election were defeated by narrow majorities. M. P. Slattery was defeated in the first ward by M. J. McKennis and H. L. Heade was defeated in the second by Asa T. Patterson.

Patterson is an attorney with political ambitions, looking, some say, to the district attorneyship, and others say to the judgeship. That he will be a candidate for the latter position this year is hardly probable, from the fact that friends of Judge Winchester, who is also a candidate for the judgeship, are in the majority, as against the Register candidate, whose election it was said would give Register too great a boom for the judicial nomination. Judge Winchester has a candidate for re-election, and has a following of independent republicans and would also, it is likely, be satisfactory to the democrats. Thus the judicial nomination in the Missouri slope appears to have scored the first fall.

The Fight for a Judgeship.

The judicial convention has been called for May 21 at the courthouse in Mandan. There will be thirty-five delegates in the convention, of which Morton will have nine, the greatest number in any county. Burleigh, Stark, McLean and the other larger counties have five each. The fight will be for the republican nomination, as that is nearly equivalent to election. It has been reported that Register would not be a candidate unless he received the republican nomination. There is much interest among the candidates, and as to the complexion of the delegations.

Judge Winchester has heretofore received the republican nomination without any great opposition. In the convention of this year another effort will be made to wrest the nomination from him. A hot fight is being put up in Morton county by J. S. Green, Walter Parkin and others against the republican party of the county. Green and Parkin are both republicans, but they seem to have scored first blood in the election of Louis Connolly for mayor over P. W. McGillis, who was the candidate of the Tuttle faction.

The Green-Parkin fellows say this is a straw showing the way the wind blows, while the other fellows assert it is only a local matter. The republican party of the way county politics are trending. McLean county has always been in the doubt. McLean has always been in the hands of the republicans, but he should have Morton to be assured of a majority in the convention.

Emmons and Kidder. There is some political interest in Emmons and Kidder counties. In Kidder, Pat Lyons is a candidate before the republican convention for re-nomination as a member of the legislature, and in Emmons county, Editor Streeter of the Emmons County Record announces himself as a candidate for the state senate. This year it was supposed that if the opponents of the Kennedy faction won in the municipal campaign, Hanna would be a candidate for congress against Spaulding and the Cass county delegation would have been practically certain to have assured his nomination.
