SPECIAL SESSION AT MADISON

CONTINGENCY OF IRREGULARITIES IN TREASURER'S BOOKS.

Governor and Attorney General Hold That Impeachment Proceedings by the Legislature May Be Necessary for Removal of the Official—Vacancy on the Ticket Soon to Be Filled.

Special to The Journal. Madison, Wis., Aug. 4.—A special session of the legislature is one of the contingencies which may arise over the fact that the land sales record books of John J. Kempf, state treasurer, have failed to balance. For ten days Governor La Follette and Attorney General Sturdevant have been looking up the law.

Mr. Kempf in his official status is coordinate with the governor and it is said the governor and Mr. Sturdevant are both of the opinion that impeachment proceedings by the legislature may be necessary for the removal of Mr. Kempf if cause should exist.

It is announced that the La Follette state committee will meet in Milwaukee in a few days and fill the vacancy on the ticket caused by the resignation of Mr. Kempf, who resigned on discovery of the supposed shortage of \$2,400 in his accounts.

Figured He Can Keep Many From Voting for La Follette.

LA CROSSE, WIS.—The democrats of La Crosse county are making elaborate preparations for the opening of the campaign in western Wisconsin on Sept. 17, when a large rally will be held in connection with the congressional and county conventions, which will be held on the same day. There is talk of having William Jennings Bryan come to the county for the purpose of keeping in line all democrats who are dissatisfied with the republican party in the last two campaigns.

Madsen says he has obtained indisputable evidence from remarks made by Rawlings in his sleep and also confessions that the prisoner is a murderer and that a price of \$3,500 is set upon his head in Wyoming.

Madsen says that he first heard Rawlings talking in his sleep of killing a man and that he gradually wormed a confession out of him. He asserts that Rawlings said that he and others had been hired for \$500 apiece by a prominent Wyoming stockman to kill a well-known sheepman, and that they stole up to the man one night in May and filled him full of lead, escaping with the price agreed upon, believing that their man was killed.

Madsen says he began to watch Rawlings carefully, and that on Monday Rawlings tried to strike him with his fist, but that Madsen dodged and was cut from the wrist. Thereupon he struck Rawlings down, tied him hand and foot and carried him to Bridger. Deputy Sheriff Pauley came with them to the jail, and Rawlings admitted in jail today that he had made such a confession to Madsen, but said it was only a "josh." He says he has never been in Wyoming, except in passing thru on a train, and that he came from his home early in May, with George Ashley and another fellow whose name he cannot remember. He left his two companions in charge of the Caribou county to work for Madsen. Ashley and the other man went to Glendive to get work at shearing.
