E. T. Cook, street commissioner of Sloux Falls, was formerly a guard at the penitentiary, and has a vivid recollection of White. I refused to take him out in my squad unless provided with extra precautions. These were not fortheoming, and I was let out. I think the penitentiary officials have become convinced that I was right. I told them that White was the most desperate man in the institution. In fact, he was simply a demon. He did not care for anything. While I was connected with the institution he made more trouble than all the other prisoners put together. The end has been as I expected. I had always thought that White would kill some one or be killed himself."

FORGED NAMES FOR GOODS Daring Operator Uses Gredit of Stephenson's Company as Cloak.


