### SCOTT DEFENDS LOGGING SCALE

DENIES RECENT INSINUATIONS OF FRAUD AND COLLUSION.

Sales to and Operations of the Weyerhaeuser Pronounced Straightforward and "Above Board" in Every Respect—Rights and Holdings of the Indians Carefully Guarded.

To the Editor of The Journal: Sir: In the Dec. 31 issue of The Journal there appeared under the caption of "Family Circle in Logging Scale" an article signed "Scott" which was a gross insult to me and my family. The article was written for the purpose of charging fraud and collusion against the Weyerhaeuser family and myself as acting Indian agent for the Chippewas.

The dates of sale of the Chippewa timber and passage of the Morris bill, and the geological record of the Marshall article. It is absolutely unnecessary for me to appear in defense of the Marshall family, father and sons, as they are quite capable of taking care of themselves under any conditions and at all times. Their records in the public domain are open to all eyes and are as clear as the sun. Neither do the Weyerhaeuser require my assistance in anything, but I would like to point out a few things which exist in the public mind about you which I do not care to see them.

The article says: "The competing lumbermen declare they could not afford to bid as much as the Weyerhaeuser people for reservation timber. How did they bid? If they did not bid more than the Weyerhaeuser people for it? Anyone who knows anything about the sale of the timber among other governmental lands is aware that there is no collusion in it. In the forestry reserve, on which particular stress is laid, the Weyerhaeuser did not buy a great deal of timber. The lumbermen who were not very big, nor were they very rich, nor were they very powerful. No very great amount of steeling could possibly be done by Ed Marshall up to the present time.

Disclaims Authority. Quoting Mr. Stuart says: "there are two sets of scales; one Weyerhaeuser set and one for the government; that the entire work is under my supervision. ### PLAN NEW CITY TO RIVAL MOBILE

IOWA MEN BUY PENINSULA, BASE OF MOBILE BAY.

Dream of Colonel John K. Lee May Yet Be Realized—Best Dock Facilities Along the Gulf Coast Bought by the Northerners—L. & N. Road Extending to the Site.

Special to The Journal. Sioux City, Iowa, Jan. 17.—Formal announcement has been made of the purchase by Sioux City men of the twenty-mile peninsula which forms the base of Mobile bay, and their determination to make a new city there that will rival Mobile.

Owing to the difficulty in keeping the dredged channel at Mobile open, it was thought by years ago by Colonel John K. Lee, who was associated in the management of the O'Neill Short Line, west of here, that the Mobile bay port of the future would be at the mouth of the bay, where the water is fifty to sixty feet deep, affording better dock facilities than any point along the Gulf coast.
