

FINE FARM LAND MAY BE OPENED

Nelson's Reservoir Bill Would Put Settlers on Northern Minnesota Tracts.

By W. W. Jermans. Washington, Feb. 4.—Passage of Senator Nelson's bill to restore reservoir lands at the headwaters of the Mississippi and other rivers in Minnesota to homestead settlement and entry, will throw open about 16,000 acres of the most tillable land in the state.

Nelson Worst Hatched. Senator Nelson beat Secretary Hitchcock out by a nose last week, when he secured the passage through the senate of his bill granting a school district in Roseau county four acres of land in an Indian allotment near Warroad for school purposes.

COLD TO HANG ON FOR ANOTHER DAY

Weather Sharps Unable to Explain the Meteorological Varieties Thruout Country.

Washington, Feb. 4.—The reports to the weather bureau show unusual meteorological conditions thruout the country particularly the development of an abnormal cold spell in the north central states despite the absence of any general storm, and this extreme cold has spread thru most of the United States during the past four days.

The coldest weather of the winter has prevailed in the central and eastern districts and in the last twenty-three hours snow and sleet has extended almost to the coast line in the east gulf and south Atlantic states.

SCORES VICTIMS OF QUEER WRECK

Explosion on One Track Derails Train on the Other—Cars Hurlled in Air.

Utica, N. Y., Feb. 4.—Two trainmen lost their lives and a score of passengers were injured today in a wreck on the New York Central Railroad at Whitesboro, three miles west of here. None of the injured were dangerously hurt. As the Western express was passing the Buffalo special east-bound, the boiler of the locomotive of the west-bound train exploded. The force of the explosion and the upheaval of the engine threw the entire east-bound train of thirteen cars from the rails. The west-bound train did not leave the track, but the cars stopped with a shock which threw the occupants of the berths backward with great force, in some cases tossing them out of the floor.

DIVORCE REFORM LAWS IN SOUTH

Texas and Missouri Legislatures Have Bills to Discourage Progressive Remarriage. Austin, Texas, Feb. 4.—The senate of the Texas legislature yesterday passed an antidivorce bill which, if it becomes a law, will do much toward ending the divorce scandal in this state. The measure prohibits a marriage within three years on the part of the person complained of in the proceedings, and the plaintiff must not marry within a year from the date of the divorce. It is provided that if the defendant is not present in person he or she may have a new trial within a year after the decree is granted. It also is required that a statement of facts and conclusions of law be filed in each case. For disobedience of any of these provisions a penalty of from two to five years in the penitentiary is provided.

MICHIGAN WARS ON ILLEGAL FISHERIES

LET ADIANS PICK CHURCH SCHOOLS

Washington, Feb. 4.—President Roosevelt has sent a letter to Secretary Hitchcock on the subject of authority for granting contracts for the education of Indians in denominational schools. The president says that inasmuch as the legal authority exists to grant the request of the Indians, unquestionably they are entitled by moral right to have their money used to educate the children at the schools they choose. The president directs that the interior department continue the practice unless congress directs otherwise or the courts hold that the decision of the department of justice is wrong. The president also urges the passage of the Lacey bill, authorizing the allotment of annuities in severalty to the Indians in the same way as their land is allotted.

BOWEN EXPECTS TO BE TOLD TO LEAVE

Venezuelan Affairs Near Crisis and Castro Is Likely to Make an Exhibition.

New York Sun Special Service. Washington, Feb. 4.—Dispatches received from Minister Bowen today, suggest that the Venezuelan situation is grave. President Castro is expected back in Caracas today, and the information from Mr. Bowen is that he will not be surprised if he then is handed the passport which Bowen does not believe Castro is acting in good faith in his informal offer to arbitrate all the disputes, except the asphalt controversy, but that he is playing only for delay. From another source the exact nature of which is not divulged, the president has been told that Castro wants to be coerced in order to avert revolution. State department officials are a little skeptical in this theory, but the president thinks there may be something in it. Mr. Roosevelt has held a conference at Secretary Hay's residence, and Santo Domingo were the subjects discussed.

The story spread broadcast that I have ordered Gorky to be court-martialed and shot is a baseless fabrication invented by persons who are grossly ignorant of Russia, or else they would know that it is impossible for a representative of the Russian administration to order any prisoner to be executed or even to decide the form of trial. Yet I am in receipt of letters daily from abroad imploring me to spare Gorky's life. I repeat that I am in no way concerned in this matter. I even do not know whether the procurator general may decide provisionally to release Gorky, as he did in the case of Hesse, Mikolain and Karekin. I cannot, of course, reveal the exact terms of the accusation against the prisoner, but you may emphatically contradict the version of the discovery of documents implicating eight men who were to have composed a provisional government."

ARGENTINE QUELLS MORE LEAKS FROM THE SCHOOL FUND

Plot of Outbreak Revealed to Government in Time to Checkmate Moves. Buenos Aires, Argentine, Feb. 4.—An insurrection has broken out in this province. Several police posts have been attacked by bands of about thirty men each, but the assailants nearly everywhere were repulsed. Two posts which were surprised were recaptured by the police. An attack on the arsenal was also repulsed. It is rumored that two regiments of troops have mutinied and are marching on the capital. The Argentine government, which appears to have been acquainted with the plans of the leaders of the plot, took timely measures to suppress the uprising and seems to have complete control of the situation. The government has issued a decree establishing a state of siege for thirty days thruout the whole republic and has ordered the mobilizing of the national guard. As to certain items the Iverson statement said: "No information could be obtained concerning the cutting mentioned."
