

LATEST CRUSADE OF NORTH DAKOTA'S COMMISSIONER. Representatives of Patent Medicine Houses Drop Into Fargo to See the Official Who Does Things—Amendments Putting Burden of Proof on the State Is Rejected.

Sentences by Kneeshaw. Judge Kneeshaw has been holding court in Fargo for Judge Pollock, who is at Pembina presiding at the Bacon murder trial. William Mullen, who stole the dishes that were sold to Mrs. Snyder, was given thirty days and fined \$100.

REAL MAYOR NECESSARY. Special City Election to Be Held at Lisbon on Feb. 27.

LISBON, N. D.—At a special meeting of the city council last night, a city election was called for Feb. 27 to elect a mayor. Frank P. Beck, the former mayor, qualified as a candidate on Jan. 2, and thereby became ineligible to act as mayor. Since that date T. C. Patterson, son, president of the council, has been acting as mayor. However, the banks have refused to cash several large warrants signed by acting mayor, acting on the advice of lawyers, who say that such warrants are invalid and that all meetings of the council held since Jan. 2 have been irregular. A mayor will therefore be elected at the special election, all bills re-audited and new warrants drawn and properly cashed. Candidates have as yet announced themselves, but the names of T. C. Patterson, W. L. Williamson and A. E. Jones are mentioned.

The Gem City bakery was today sold to S. P. Kelly of Granite Falls, Minn. Bert Wick, the former proprietor, will go west in the hope of restoring the business. The Jones Lumber & Implement company, a new mercantile corporation, has commenced business, and will deal in hardware, farm machinery, lumber and coal. A. E. Jones of A. E. Jones & Co., real estate dealers, is president of the new concern, and his brothers, Charles E. and Freeman J. Jones, will assume active management of the business. Thousands of bushels of Ransom county durum wheat have been sold at fancy prices for seed, and deliveries are now being made, several carloads going as far as Washington and more to Minnesota and points in the northern part of North Dakota. Several farmers here deal exclusively in rare seed grain, and Ransom county seed is becoming well known through the northwest.

FARMERS WANT AN ELEVATOR

Movement at Vermillion Is Taking Definite Shape. VERMILLION, S. D.—There is a disposition on the part of farmers in this vicinity to purchase or erect an elevator in Vermillion. They have been considering the proposition for some time, but matters have only now taken on a definite shape. One of the elevators in this city can be purchased at a reasonable figure, and the farmers can begin business at once without waiting for an elevator to be erected. Secretary George Harris of the State Blacksmiths' association says that a wrong impression has gone out concerning the movement to suit the farmers. He says that the purpose of the organization through the state has nothing to do with raising prices, but to make prices uniform in each county. He says the only advance in price is in shooting horses, and in this the blacksmiths are justified, owing to the recent 50 per cent rise in the price of shoes.

Petition is being circulated here for signers praying that the legislature strike out the words "medical attendance" from house bill No. 77, which brands the head of a family as a criminal for neglecting to have "medical attendance" summoned in case of serious illness in his home. It is said that the bill is a blow at the Christian Science and osteopathy. The petition is being generally signed here. Professor E. C. Perisho of the geological and astronomical chairs in the state university does not believe that the cold weather is due to the presence of spots on the sun. He says: "There is nothing strange about this spot except that it is unusually large, for they frequently appear on the sun. They are caused by storms of some sort, resulting in an agitation in the outer atmosphere. This, perhaps, boils the atmosphere, causing the sun spot to look black. This is the largest spot seen in years. The only effect these phenomena have on the earth is electrical, so far as known. At times when spots on the sun are large or numerous, telegraph instruments have been burned out and electric currents otherwise affected. At such times the aurora borealis is unusually active also. Scientists do not believe that sun spots affect the temperature or weather on the earth."

SUFFRAGE BILL IS LOST AGAIN

MONTANA HOUSE DECIDES AGAINST THE AMENDMENT. Women Crowd the Galleries and Lobbies While the Bill Is Discussed in Committee of the Whole—Hearty Applause for Members Who Favored the Measure.

Helena, Mont., Feb. 15.—For two years at least the question of female suffrage will not be submitted to the voters of Montana in the shape of a constitutional amendment, the house in committee of the whole late yesterday having decided by an emphatic vote against the bill introduced by Representative Berry of this county. The bill was made the subject of an acrimonious debate, in which most of the members participated. It had been made a special order and standing-room was at a premium, women crowding the galleries, lobbies and even invading the floor.

Divorce Bill Recommended. The house in committee of the whole recommended for passage Representative Bennett's bill to prevent divorced persons marrying again. An amendment was adopted by which the plaintiff in a divorce suit where the grounds are adultery may marry again, but the defendant cannot marry again except on the death of the plaintiff or until proof is adduced that the plaintiff has married again and that five years have elapsed since the divorce was granted, during which time the uniform good behavior of the defendant must be proven.

The bill had a narrow escape from being unfavorably reported a week ago, but was ordered printed, and has now been recommended for passage.
