Special to The Journal. Pierre, S. D., Feb. 23.—The prospect for some revenue legislation is excellent, and conditions will be vastly improved if not quite relieved. Of course it will be necessary to provide a deficiency levy for this year, and ways and means committee has brought in a bill providing for a two-mill levy for 1905.

This, upon the basis of the present assessment, will produce \$420,000, but it is believed that the other new revenue provisions will vastly increase the assessment. Some members of the committee are sanguine enough to believe that the next assessment will reach \$300,000,000.

A distinctly revenue measure the tax ferret bill and the bill making the state board of equalization a board of assessment, and providing for the standard of assessment, have passed the house. Senator

Willon's bill, empowering all boards of assessment to assess all property in the state, has been favorably reported in the senate, and has been passed by that body. At present the exemption in the \$5,000 limit on the bill, there will be some opposition to this low limit, and it is possible that a higher figure, say \$10,000, will be set in any event. The bill will produce much revenue for the state.

The members of both bodies are to be commended for the unusual spirit manifested in consideration of these bills, many voting cheerfully for measures that promise to increase their personal taxes.

The House and the Primary. The passage of the primary election bill in the house was in contrast with the interest involved in the adoption of the committee report. There had been a good deal of quiet logging, but when the order was reached and the long bill had been read not a word was spoken upon the merits of the proposition. The roll was called, forty-five votes being requisite to the passage of the bill. Several passed upon the first call and many busy pencils kept tab upon the result.

At the reporter's table C. J. McCleod and O. M. Gehring sat beside each other marking the same sheet. With the second call finished, but forty-four had voted, and apparently the bill was lost. Just as the clerk was about to announce the vote, Charles Rose and announced that there were members present who had not voted, and demanded that they be required to vote. Before action could be taken Walker stood in his place and desired to be recorded as having carried the bill, and it was promptly clucked by tabling reconsideration.

Bills Passed. The senate passed house bill 144, the dipping plant bill, also house bill 95, providing that administrators and guardians may sell the property of children and incompetents under certain conditions, also house bill 75, providing punishment for securing public aid under false representations.

The house passed senate bills as follows: Senate bill 37, providing that banks be relieved from responsibility for the payment of returned checks unless the depositor returns the bank within ninety days after the return of the check; also senate bill 129, providing that attorneys admitted to practice in another state must have five years regular practice before he will be admitted to practice in a court upon motion without examination.

NONPARTIZAN MOVEMENT. Marshfield Would Save Expense of Holding a Primary Election. MARSHFIELD, WIS.—Pursuant to a call issued by the democratic and republican city committees, a meeting was held at the city hall for the purpose of ascertaining the sentiment of the citizens of Marshfield as to the advisability of placing a nonpartizan ticket in the field at the coming municipal election and avoiding, if possible, the expense of holding a primary election.

The only opposition came from a "halfbreed" resolution to establish a committee of three over the movement, a special committee of three was appointed to take the initial step in the matter of choosing citizens' candidates.

This committee will select a committee in charge of the movement for the purpose of "fairness" and one "unfair." The ward committee of the democratic party, consisting of voters at which candidates for the ward offices will be chosen.

If the plans go thru as outlined, candidates who fail to get on the citizens' ticket and are determined to run will have the alternative of filing out nomination papers and running as independent nominees.

NONPARTIZAN MOVEMENT. Marshfield Would Save Expense of Holding a Primary Election. MARSHFIELD, WIS.—Pursuant to a call issued by the democratic and republican city committees, a meeting was held at the city hall for the purpose of ascertaining the sentiment of the citizens of Marshfield as to the advisability of placing a nonpartizan ticket in the field at the coming municipal election and avoiding, if possible, the expense of holding a primary election.

The only opposition came from a "halfbreed" resolution to establish a committee of three over the movement, a special committee of three was appointed to take the initial step in the matter of choosing citizens' candidates.

This committee will select a committee in charge of the movement for the purpose of "fairness" and one "unfair." The ward committee of the democratic party, consisting of voters at which candidates for the ward offices will be chosen.

If the plans go thru as outlined, candidates who fail to get on the citizens' ticket and are determined to run will have the alternative of filing out nomination papers and running as independent nominees.
