BINDER TWINE, 11,000,000 LBS.

THE OUTPUT OF THE STILLWATER PRISON FOR 1905.

It Is the Largest Since the Factory Was Established—All Stored Stock Sold—The Oak Glen Farm Owned by David B. Staples Suggested as a Site for the Proposed New Prison—The Present Building Inadequate.

Special to the Journal. Stillwater, Minn., July 27.—The binder-twine season at the prison for 1905 is practically over. All stock that was stored has been shipped and shipments now are confined to the daily output. The season's output is about 11,000,000 pounds and is by far the largest output for any year since the prison factory was established. Most of the twine was sold in carload orders to farmers' clubs, but there were also large shipments of small cash orders. As soon as shipments for this season are over the factory will begin turning out twine for next year. The money for the purchase of a new site for the proposed new prison became available Aug. 1, and the board of control will as soon as possible determine which site to select of those that have been offered. The prison population has been increasing rapidly during the past year or two and the present cell building is entirely inadequate, and many of the inmates are unable to obtain cells, but are required to sleep on cots in the corridors. The population at present is 712. David B. Staples presents the suggestion that he ask the board of control to high a price for a portion of his Oak Glen farm as the most available site. He says the

OUYANA IRON RANGE

New Crow Wing County Deposit May Make Many Rich. DULUTH, MINN.—Favorably located in the Ouyana iron range in Crow Wing county are an eagerly sought and bid for as lands on the Mesaba a dozen years ago. Lands were known to be worth from \$10 to \$12 an acre stand a show now to bring from \$100 to \$150 an acre. One of the most interesting examples is that of the option for sale given by Fred and Christ Eric, who by the purchase of 280 acres immediately southeast of Rabbit lake in Crow Wing county. Under Adams of Duluth is said to have proved up about 3,000,000 tons of ore directly south of the lake and the lands by the Eric brothers is favorably situated with reference to the ore deposit. No less than half a dozen enterprising prospectors have been trying to get an option on the Eric brothers' land, and George Croston of Duluth at last was successful. His option is for the payment of \$20,000 for the property, providing, after exploring the land, he wishes to exercise it. If it proves to be a productive mineral range, it will mean many millions of added, and hitherto unknown, wealth to the state.

SHIPPING ORE WEST

Colorado Fuel Needs Heavy Tonnage from Superior Range. DULUTH, MINN.—The purchase of 25,000 tons of Lake Superior iron ore from Corizgan, McKinley & Co. by the Colorado Fuel & Iron company was necessary because of the practical exhaustion of its own supply. It is probable that the company will make additional and larger purchases of Lake Superior ore until such time as it can exportation ore deposits south of this place. This is the first time that Lake Superior ore has ever gone as far west.

NORTH DAKOTA OLD BATTLE OF WHITE STONE

DISPUTE IN NORTH DAKOTA AS TO WHERE IT TOOK PLACE.

Citizens of Sargent County Think that the Wrong Spot Has Been Granted to the State by Congress in the Dickey County Site—A Claim Made that the Battleground Was Near Gwinner.

Special to the Journal. Kindred, N. D., July 27.—Not long ago congress granted to the state of North Dakota a tract of 640 acres of land upon which the old-time battle of White Stone Hill is supposed to have been fought. The engagement took place Sept. 3, 1862, between a detachment of United States soldiers and a body of Sioux Indians, and resulted in severe losses to the latter. The tract granted to the state by congress is located in Dickey county, and Governor Barlow has recently appointed a body of commissioners to superintend its improvement in the matter of enclosure, the planting of trees and the erection of monuments.

In the meantime a stout protest is offered by the citizens of Sargent county. It is asserted on what seems to be good authority that the White Stone Hill, a range of hills in the center of Sargent county, is the spot where the battle was fought. This claim is further substantiated by the fact that Sargent county lies nearer the center of the North Dakota valley of which it contained the only bona fide settlements in the state in the early thirties. Again, an old army trail is traced from the center of Sargent county in a northwesterly direction into Sargent county and thru the very spot where it is claimed the fight occurred and which place numerous skeletons and utensils of war have been unearthed during the past twenty-five years.

THE APPLE RIVER DAM

A Well-Known Legal Case to Come in Trial Again. Hudson, Wis., July 27.—The case of McDonough vs. the New Richmond Roller Mills comes up for trial in the county court of St. Croix county Tuesday next. The controversy is of two years' duration and has attracted wide attention, having already, in a different form, been tried in the circuit court and by the state supreme court at Madison, Wis. In 1903 the New Richmond Roller Mills constructed a dam on the Apple River, five miles above New Richmond, to obtain waterpower for an electric plant. This caused the water to submerge a part of the McDonough estate, and Charles McDonough began action to compel the mill company to remove the dam. He lost, but the supreme court reversed the decision of the circuit court. Senator Frear brought action against the mill company in the name of the heirs of Charles McDonough, and this is the case coming on Aug. 1.
