CITY NEWS

ACCUSED OF TRICKERY

SPIRITUALISTS' NATIONAL CONVENTION RECEIVES BOARD'S JUDGMENT AGAINST ST. LOUIS MEDIUM.

Formal recommendation was made to the National Spiritualists' association today in convention at the Unitarian church, by its credentials committee, that Mrs. Josie K. Folsom and C. K. Stewart (her husband) be not allowed seats as delegates.

The report of the committee stated the credentials of the two from the Truth Seekers' society at St. Louis were in proper form, but that your committee takes the position that if they are unfit to represent spiritualism as its ministers, they are also unfit to represent it in its legislative body. This reference was to the findings of the national board of trustees, that they are "guilty of counterfeit mediumship and fraudulent practices." The committee report also recommended the two be given a fair showing by the allowance of a half hour before the convention to present their grievances, an equal space to be allowed the committee to defend its findings. Attorney Louis Williams of Minneapolis then took the floor for Mrs. Folsom and Stewart, and requested time in which to confer with his clients before presenting his argument. This was granted. It is probable Mr. Williams will be heard late today.

The defense will be that the National association, without changing its rules, cannot disfranchise delegates who have been sent with proper credentials and who are representatives of a duly recognized society, unless the charter of such society be revoked.

The convention this morning, on suggestion from President Barrett, went on record in support of President Stewart's action in bringing to the close the Russo-Japanese war. "The last few months," said Mr. Barrett, "this country has been treated to one of the most glorious bloodless victories of the world by President Roosevelt's successful efforts to bring to an end the Russo-Japanese war. I suggest the resolutions committee prepare appropriate resolutions for me to bring to the attention of the convention, showing our approval of his splendid services for peace on earth, good will toward men." The suggestion was adopted.

After considerable discussion the convention authorized its incoming national board of trustees to confer with the postal authorities with a view to having the use of the mails refused to papers carrying advertising of counterfeit, commercial mediums. "The discussion on this subject was very lively," Attorney J. Halbert of Iowa condemned such mediums as "stealing the liver of heaven in which to serve the devil."

Mrs. Laura G. Fixen was today elected the Spiritualists' delegate to the Federation of Women's clubs, and John W. King delegate to the Sunday School union now in session.

BENEFITS OF DIVORCE

Former Methodist Pastor Thinks Divorce Not Unmitigated Evil.

Rev. B. F. Austin, a former Methodist minister but now a strong advocate of the doctrine of Spiritualism, gave an address at the Spiritualists' convention last evening on the "Divorce." He spoke of the divorce as a proof of the advanced stage of present civilization. He said: "Spiritualism, holding to the doctrine of absolute liberty of man, woman and child, asserts that no man or woman should be compelled to live a lifetime in domestic hell because in their ignorance or blindness they have entered upon a foolish or unnatural contract. Yet so sacred and so many are the interests involved that no one should lightly make or break the marriage bond."

STATE TREASURER

TO BE ENJOINED

FORMER GOVERNOR WHITE SPRINGS A SURPRISE.

Promises to Stop Payment of All State Warrants and Bonds Pending a Decision of the Courts Regarding the Legality of the Recent Sale of School Bonds.

Helena, Mont., Oct. 18.—State Treasurer J. E. Rice has been advised by former Governor B. F. White of Dillon that he would soon enjoin payment by that official of all state warrants and bonds.

Mr. White is a member of the board of trustees of the state normal school, whose bond issue of \$75,000, authorized by the recent legislature, was declared illegal in an opinion by Attorney General Olson, as well as other bonds to the amount of \$495,000. These bonds had been taken over by the state, and new buildings are being constructed at Dillon with the proceeds of the sale.

Since receiving the opinion of the attorney general the state treasurer has refused payment on all warrants drawn on that fund. While warning the treasurer in a letter that if he pays any more warrants he and his bondsmen will be held responsible, Mr. White is one of the most substantial men in southern Montana, declares that warrants are just as much a liability against the state as are bond issues, and if the state has overstepped its constitutional limit in the indebtedness of one it has in the other, and he says he proposes to have the matter determined once and for all.

"If," says Mr. White, "it is disposition in land grants against the state as are bond issues, and likewise it is disposition to pay state officials."

The letter created some excitement at the capitol, and the threatened cessation of payment was not a pleasant matter for the state. State Treasurer Rice referred the letter to Attorney General Olson with a request for an opinion as to the duty in the matter. The question is a momentous one, and will doubtless go to the supreme court for final determination, both as respects the bonds issued for educational institutions and warrants for payment of state officials.

Government Gets Busy.

United States Attorney Beach has instituted a number of suits against residents in Missoula county, alleging trespass in which the government seeks to recover the value of cordwood and railroad ties cut from the public domain. A more important suit is that against Lewis K. Megard and the Missoula Mercantile company, in which it is alleged that Megard cut 17,125 railroad ties and sold them to the mercantile company. Suit brought to recover their value, together with costs. Another suit is against Simon Hillman, who is alleged to have cut 180 cords of wood. Indictments were returned by the grand jury against Megard and Wallman on the charge of trespassing, and these are now pending in the federal court. Criminal complaint has been filed against Hillman on a similar charge, and this will come up soon before the commissioners at Missoula.

PARENTS GO TO PRISON

Pathetic Parting in Butte Court Between Mother and Child.

BUTTE, MONT.—Mr. and Mrs. John Walters were each sentenced to five years in the penitentiary for forgery yesterday afternoon. They have a 6-year-old daughter and the mother is a widow. Walters was charged with forgery of a check for \$100.00, and the mother with forgery of a check for \$100.00. The child was permitted to see her parents in jail while they were under arrest here.

An announcement was made last night that the stock and fixtures of the Case, Greville & Ervin company had been sold to the Symons company. The stock was sold for \$10,000, and the fixtures for \$10,000. The Symons company is one of the largest dry goods establishments in the city, but it was destroyed by fire last September.

MINNESOTA LUMBERMEN BUY VANCOUVER TIMBER

The largest timber deal in the history of British Columbia has been just completed by the sale to Minnesota interests, presumably the Weyerhaeusers, of 43,000 acres of timber lands on the eastern coast of Vancouver island. The tract, which is said to contain 1,000,000,000 feet of standing fir and cedar of the best quality is located between Salmon river and Campbell river. The purchasers are planning the erection in Vancouver of the largest saw mill on the Canadian coast, with an estimated annual output of 70,000,000 feet per annum.

GUNARD LINE OFFICE HERE

MINNEAPOLIS WILL BE NORTH-WESTERN HEADQUARTERS OF TRANSATLANTIC STEAMSHIP COMPANY.

With a desire to have a freight as well as passenger representation in Minneapolis, the Cunard Steamship company will open northwestern headquarters here Jan. 1, 1906. The location is yet to be selected. Ernest Carley of Chicago will come to Minneapolis as manager of the northwestern department of the company. With him will be associated Thomas G. Newgard and Bernard G. Benson.

The A. E. Johnson company, which has represented the Cunard company as general northwestern passenger agent for several years on a commission basis, did not feel it could give the Cunard line a suitable freight representation on such a basis and therefore the Cunard will open its own office. The Johnson company was moved to this step also by the expansion of its own business in various new lines.

Ernest Carley, the new manager, is now connected with the freight department of the International Mercantile Marine company and formerly was manager of the Dominion line in Chicago. Thomas Newgard, one of the assistants, has been connected for eight years in various capacities with the A. E. Johnson company. Until a year ago he was northwestern traveling passenger agent, when he resigned to go into business. B. G. Benson, also to be an assistant in the office, represented the Johnson company in St. Paul for several years, and is now traveling passenger agent for the Allan line, with headquarters in Minneapolis.

Mr. Carley was at the West hotel yesterday and stated that Minneapolis appeared to be a natural selection for the Cunard northwestern office. The company will handle passenger bookings as well as make arrangements for the importation or exportation of freight. The fact that Minneapolis has numerous flour mills, which do a large export business, was a factor in the decision of the Cunard people to make their office here.

G. A. R. CAMPFIRES

All Over the State Old Soldiers Are Strengthening Organization.

Campfires are being held all over the state under the auspices of Minnesota department of the G. A. R. For the purpose of enrolling every civil war veteran in the ranks of the Grand Army, in order to make a strong showing for the state at the national encampment of 1906, which will be held at Minneapolis. Not only old soldiers, but members of the Woman's Relief corps and all those are invited to attend the campfires and all which have been held heretofore have been most successful. Adjutant General O. S. Clark has been present at all of them, while Department Commander C. F. McDonald and other department officers have attended as many as possible. Chatfield will have a campfire tonight, Pipestone on Oct. 23 and Duluth on Oct. 25. Similar reunions have been held at Spring Valley, Brownton, Annandale and Staples.
