

At Lupski, 3,000 Mariavites attacked 2,000 Catholics, and a pitched battle followed during which three men were killed and forty wounded. The fighting is proceeding today.

HUNDREDS KILLED BY EARTHQUAKES

The casualties and damage done are reported to have been heavier than those of the last earthquake. As a result of the earthquake in Formosa last month, 1,014 persons were killed, 695 injured and 1,200 houses were demolished. The prosperous towns of Dayto, Rayshiko and Shinko were completely destroyed. The damage done was roughly estimated at \$45,000,000.

COURT CLAUSE TO AID OF RATE BILL

President Favors Amendment Designed to Prevent Loss of Time in Injunction Proceedings.

Senator Nelson Sent For to White House Conference on Measure.

Washington, April 14.—President Roosevelt has intimated to Senator Nelson, who called at the White House yesterday on invitation, that he would be glad if the republicans of that body favoring the so-called administration policy, would consent to an amendment to the rate bill which will be offered by Senator Simmons of North Carolina, or Senator Mallory of Florida. This amendment is designed to obviate the loss of time in the case of temporary injunctions. It provides that all proceedings for these injunctions must be taken before the rate fixed by the commission goes into effect. The complainant must begin proceedings within fifteen days after the fixing of the rate. Ten days are then to be allowed for the taking of testimony and the return of the usual papers, and in thirty-five days all the facts are to be ready for the court in which the application for temporary injunction is to be made.

OPPOSES BAILEY AMENDMENT

President Urges Democratic Senators to Kill Bailey Amendment.

Washington, April 14.—Senators Simmons and Overman, both democrats, were at the White House today, while Mr. Roosevelt urged Senators Simmons and Overman to keep their associates from supporting the Bailey amendment to prohibit circuit courts from granting preliminary injunctions. He said this plan does not mesh with his approval and he hoped the democrats will not give it such strength as to make it seem a minority suggestion. In this connection, it can be said the democrats are by means nearly unanimous in favoring the Bailey amendment. There is much opposition to it among the minority. It is necessary for twenty-two democrats to agree on the Bailey amendment if it is to be terminated to have a caucus and make it

SPARTAN MOTHER GIVES BOY TO PRISON KEEPERS

Lincoln, Neb., April 14.—Roy Carver, an escaped convict from the Nebraska prison, after enjoying his liberty for four days, was recaptured last night and taken back to prison. Carver went to the home of his mother in Lincoln and asked for a change of clothing that he might escape detection. He was given a mother's welcome, after which she telephoned to the penitentiary authorities and detained him until an officer came and took him into custody. Carver is only 22 years old. He was convicted of burglary and sentenced to serve two years. At the prison he was listed as a trusty and was permitted to wear a gray suit; now he must again don stripes.

GYPSY BAND STEALS NORTH DAKOTA GIRL

Moorhead, Minn., April 14.—Word has been received by Chief of Police Malvey, from the sheriff at Valley City, that a man named Wells, son of the "king" of a band of gypsies which made its headquarters in this city the past winter, had kidnapped a 14-year-old girl at Oriska and that his wagon outfit had disappeared. The rest of the band is under arrest at Valley City and the sheriff is preparing to scour the country for the fugitives.

300 BEASTS PERISH IN BALTIMORE FIRE

FIREMEN ARE INJURED

Chicago, April 14.—Three firemen were severely injured and a score more were bruised when the roof of a burning building on West North avenue fell last night. The men were precipitated into the midst of flames on the fourth floor, from which they escaped by sliding down leads of hose to the ground.

BAN ON SKYSCRAPERS

St. Louis, April 14.—The local building commissioner has put the ban on skyscrapers, refusing to issue a permit for a \$1,000,000 department store building unless the height were reduced from sixteen to ten stories. The promoters will take the matter into the courts.

DEAD LINE DRIVES MUTINEERS TO BAY

New York, April 14.—With ten Italian cattlemen threatening to murder him and his officers and loot the ship, Captain Marshall of the British steamship Hilarius, just anchored here, owed his deliverance from the plot to John Nerses, a Brooklyn man, who had shipped on the Hilarius at Buenos Aires as an assistant engineer, working his way and that of his wife and two small children back to the United States. The mutineers were left at Bahia, where Captain Marshall had made port at the urgent demand of the loyal members of the crew, after three days and three nights of terror on board the steamship. The Italians shipped as cattlemen at Montevideo on March 6, to take care of a large cargo of cattle while the Hilarius had taken on for Para. Twenty-four hours out of Montevideo the Italians approached Nerses, who speaks Italian fluently, with a proposition to kill Captain Marshall and his officers, loot the steamship and escape to Bahia. Nerses pretended to enter into the plot, but that night told Captain Marshall as the officers were sitting in the after section of the ship. Captain Marshall at once ordered a deadline drawn across the vessel at a point just forward of the bridge. Three of the loyal sailors on board, under the leadership of Nerses, were stationed at this line, with orders to shoot down the first of the Italians who insisted upon passing across the line. The Italians finally capitulated and were left at Bahia.

SHOT BY AN ASSASSIN

Cheyenne, Wyo., April 14.—John Boyle, a well-known ranchman, was killed last night at the Ketchikan ranch, twenty-five miles southwest of Cheyenne, while at supper, by a shot fired thru the window. The assassin escaped.

ON HORSEBACK, CHILDREN MARRY

English, Ind., April 14.—George E. Searles and Lulu Brown, both under 17 years of age, were married today on horseback in the middle of the highway. Magistrate William H. Cunningham officiated. The couple had permission from their parents, and the horseback idea was suggested as a novelty by the bride.
