

MURDER THREATS CHARGED TO THAW

Woman May Testify that Millionaire Contemplated Killing White Long Ago.

Journal Special Service. New York, July 9.—"Before her marriage to Harry Thaw, Evelyn Nesbit did make an affidavit in suit she contemplated bringing against Thaw. The suit was for breach of promise of marriage. The original affidavit made by Evelyn Nesbit is in existence today, and has not been destroyed."

These highly important statements have been made with the greatest positiveness by a man who was a friend of the late Stanford White. This contradicts the statements of Judge Olcott Harry Thaw's counsel, who said repeatedly that Evelyn Nesbit never made any affidavit against Thaw.

In this affidavit it is said she charged Mr. Thaw with having pointed a pistol at her head and threatened to shoot her if she did not immediately consent to her marriage to Stanford White of accomplishing her ruin.


This affidavit has been destroyed, but a photograph of the contents are of such a nature as to preclude publication. Threatened White, Too. A line of evidence which, if corroborated, will go far to destroy any hopes Thaw may have of escaping the law.

When she got home she went to Stanford White and told him of the treatment to which she had been subjected by Thaw. White then took her to his attorney and had her draw up the affidavit which is now so badly wanted by Thaw.

FORT SNELLING NOT TO UNDERGO CHANGE

Local Post Is Not Included in the New Brigade Location Project.

Washington, July 9.—Under the plans of the president, and Secretary Taft, for the establishment of brigade posts at various places throughout the United States, Fort Snelling is to remain practically as it is now, with only a regiment at the post, according to an official of the army, who was consulted by Secretary Taft, when he was considering details of the president's plan.

Fort Snelling was considered as one of the posts to be enlarged, to accommodate a brigade, but it was finally passed over, because there was not enough room on the reservation for maneuvering such a large force. This was apparently the only reason that the post was not selected as one of the prominent large reservations.

Among the posts for which there will be no use will be Fort Assiniboine and Keogh, in Nebraska. On the other hand posts which already have a considerable garrison, like Snelling, in Minnesota, Lincoln near Bismarck, N. D., and Meade in South Dakota, will be maintained at their present strength.

When the saloonmen gave it out, a day or two ago, that they would open under the Anderson ordinance, which the Kansas City court of appeals recently held to be valid, and which permits them to sell liquors after 12:30 a. m., orders came from Jefferson City to keep the saloons closed despite this decision.

The police department, endeavoring to obey instructions, began making arrests shortly after midnight and continued the practice thru the day. But as fast as a saloonman was released on bond, he would reopen his place. Then the officers requested him and tried to make him be good by refusing to release them on bond.

Writs of habeas corpus were applied for before Judge Ramey, who held that the police had no authority to refuse to release a man on bond when he is charged with a misdemeanor. Then Chief Franz instructed his men not to molest those who had been arrested once, but to keep a close watch for violators who had not been apprehended.

Jefferson City, Mo., July 9.—Governor Folk today issued instructions to St. Joseph, Mo., police commissioners to arrest all saloonkeepers of St. Joseph who keep open next Sunday, and if, after a third arrest, they refuse to close up, to take charge of all their stock and place it in a safe for evidence against them.

SOCIETY COUPLE IN DIVORCE SUIT

Mrs. Williams of Winona, a Leader in Humane Work, Charged with Cruelty.

Winona, Minn., July 9.—A divorce suit involving two leading society persons of Winona came up for trial this afternoon in the district court before Judge Thomas S. Buckham of Faribault. Coming to his long acquaintance with both the principals Judge Snow preferred not to try the action and asked Governor Johnson to name some judge to sit in the case. The governor designated Judge Buckham.

The action for divorce is brought by Edward W. Williams against Laura P. Williams, on the ground of cruel and inhuman treatment. Mrs. Williams has been a leading figure in the Winona Humane society for years past. Mr. Williams in his complaint sets forth that the defendant has made unjustifiable complaints against him to other persons charging him with having improper relations with respectable and well-known young women of Winona, that she has tried to alienate the affections of his daughters from him, that in fits of anger she has refused for long periods to speak to him, and that she has lived apart from him for more than a year.

In the answer and cross complaint filed by Mrs. Williams it is alleged that the plaintiff, Mr. Williams, has lived apart from the defendant for more than a year past, and she asks for a separation or for a limited divorce with allowance for suit money and alimony, and that she is allowed to furnish and household goods. It is specifically denied that the defendant has been guilty of cruel and inhuman conduct toward the plaintiff. The plaintiff is charged with having become enamored of a certain young woman, of having lavished money upon her and of having behaved himself in an improper manner when in her company. It is also alleged that the plaintiff has struck and choked the defendant and threatened to kill her.


