

TELEGRAPH OPERATOR ROSE TO BE KING

Romantic History of Dusky Monarch in France's African Dominions.

Special Cable to The Journal. Paris, Nov. 17.—There is at present in the city a monarch who at one period of his career was a telegraph operator. The story of his advancement reads like romance. Mademba is the name of this sovereign. He is of dusky hue and has from the vicinity of the Niger, near the rank of king of King of Soudan to General Archibald. When he arrived at man's estate he entered the postal service.

With his rifle in hand he constructed the telegraph lines during a period of revolt in 1880-1881. In 1887, when General Gallieni was appointed governor of the forces of the French Soudan, Mademba was made a diplomatic agent, and commanded the black troops in the expedition organized against a rebel chief. In 1890-1891 the French Soudan was still in revolt, the rebels pillaging and burning everywhere in the district of Soudan was particularly devastated.

When the rebellion came to an end General Archibald remembered the exertions of the telegraph operator. He considered that his concept of morality and authority ought to be applied to the natives. And so it came about that Mademba was made king of Soudan, the natives of the district had been burnt by the rebels. He was as subject 500 prisoners of war, bandits all, who were not worth the cord necessary for hanging them.

Once invested with royalty, Mademba set to work to make them black ruffians industrious cultivators. Soon prosperity returned to the district. The rebels and thieves speedily became thrifty workers in cultivating cotton, and fathers of families. For the rest, Mademba is a loyal friend to France. In 1896, on the proposition of General Trentinian, he was made a member of the Legion of Honor and thanked for the aid rendered to the country of his adoption.

MME. GOULD'S BARGAIN FAIR, WOMAN DECLARES American Heiress Got All that She Could Expect from Her Alliance with the Count de Castellane, Writes Mrs. Emily Crawford, Truth's Correspondent.

London, Nov. 17.—"The countess has been spoken of as the prey of an adventurer," remarks Miss Emily Crawford, Truth's famous correspondent, referring to the former Countess Boni de Castellane, now known since her divorce by her maiden name of Gould, with the motherly prefix of "madam."

"She had all she bargained for. Does any American heiress bargain for honest, quiet, connubial happiness? No. She wants a splendid stage on which to shine, in costly belongings and a grand title and in illustrious society on footing of equality."

"Did not Count de Castellane give all that to Jay Gould's daughter? She had the pick of Europe's aristocracy, her entertainments. Millions were spent—but why? To provide her with the stage for which her ambition craved."

"There is much exaggeration in what has been said against Boni. He had endless enemies in the political world, and was greatly envied. He had good qualities, but the root of his troubles was his own views of life and pure Puritan virtues do not prevail. The countess expected American virtues as well."

"Yet it is said the marriage of the countess cost her at least 40,000,000 francs (\$8,000,000). That may be well."

MAY GET 32 PER CENT Depositors of Failed Butte Bank Will Realize a Little.

Washington, Nov. 17.—The controller of the currency has made public a statement showing the assets and liabilities of the defunct Aetna Bank and Trust company of Butte, Mont., having a branch in this city. The concern closed Oct. 18 by order of the controller's office. The total assets are \$153,603.09 and the liabilities \$468,626.09.

Commenting on this condition of affairs, Controller Ridgway says: "Assuming that these estimates are approximately correct, liquidation on this basis would insure the payment of about 32 per cent in dividends to depositors and other creditors, less the cost of administration."

SERBIA FACES CIVIL WAR Bankruptcy Near, Too, Declares Well Informed Diplomat.

By Publishers' Press. Vienna, Nov. 17.—Prince George of Serbia has declared insolvency despite the aid, according to advices from Belgrade today.

"Nor is this the worst," said a well-informed Balkan diplomat in an interview. "It is not so much the prince's financial situation as the fact that he is drifting into hopeless bankruptcy. Civil war, too," he says, "is highly probable."

HORRIBLE SUFFERINGS ENDURED IN SIBERIA

Thirty-five Thousand Sent to a Living Death in the Last Eleven Years.

St. Petersburg, Nov. 17.—Siberian journals are full of the horrible suffering which the political exiles undergo in Tobolsk, Irkutsk, and other sections of that desolate land. During the last eleven months, as many as 35,000 people have been sent to Siberia. About 2,000 have escaped, but the rest remain to endure a living death. They are sent to the marshes where nothing grows but a rank grass, and where no food or craft can enable them to earn enough to prolong their miserable existence.

The Russian government allows them exactly 2 1/2 cents a day. The money sent by their friends rarely reaches them, being intercepted by the czar's officials. In summer, they keep body and soul together with fish caught in the rivers, and coarse rye bread. In winter fish is worth its weight in gold and bread is scarce. Then they eat the grass from the frozen marshes. Little wonder that scurvy, cholera and typhus rage among them.

Live in Mud Huts. This is not the worst, for they are obliged to live in the mud huts of the native Ostiaks, infected with that Siberian scourge, leprosy. It is not surprising that these exiles, most of them delicately reared men and women, have perished on the stocks of Russian fortresses for their political opinions and have thus escaped this certain, but slow, death, known as "perpetual exile."

Rebels Are Not Awed. And yet, in spite of these terrible sufferings, men and women in Russia are bent upon fighting for freedom. Within the last few weeks, 5,000 pounds of dynamite, 400,000 bullets and 4,000 rifles have been found by the police in private houses in Moscow, Petersburg and other large towns. Never before have Russian prisons and Siberian marshes been so crowded with political prisoners as at the present time.

Wolf, surgeon of the Peary Arctic expedition, an estrangement between the doctor and his fiancee has been brought to an end and the bridegroom's arrival in this city will be followed by a wedding.

THEFT OF COAL LANDS LAID TO LAND OFFICE

Steals Perpetrated with Full Knowledge of Department, Smith Says.

Washington, Nov. 17.—Affidavits are on file with the government here and have been called to the attention of President Roosevelt charging that the United Pacific Railroad company and the Union Pacific Railroad company secured illegally coal land in the state of Wyoming, valued at many millions of dollars, were perpetrated with the full knowledge of the government land office, if not with its connivance, and were known, if not tacitly assented to, by the department of the interior.

The affidavits are made by Artemus J. Smith, Smith & Bradbury, dealers in mines and mining in Denver. The charges he makes are sensational in the extreme, and call into question the integrity of William A. Richards, government and commissioner, and others high in the employment of the government.

It was the knowledge of the earlier charges made by Mr. Smith which led to the investigation made by the interstate commerce commission recently at Omaha, Salt Lake City, Denver and by which fraudulent land deals of great magnitude were uncovered.

Shielded the Department. In pursuing the investigation the interstate commerce commission was exceedingly careful not to uncover the facts connected with them, together with the names and dates and amounts paid for perjury, held in the name of the department of the interior for more than three years. Acting under the suggestion of government officials, the commission carefully avoided exposing or making a attack upon a co-ordinate branch of the government.

Emboldened by the disclosures of the commission, Mr. Smith has again appealed to the department of the interior for justice, declaring that he has a prospective interest in the land in question, and that he desires to assert and protect this interest.

Mr. Smith's charges may be summarized as follows: That on Nov. 21, 1903, he placed before the department of the interior facts and data and offered to prove, if given the opportunity, that a vast acreage of land had been and still was being stolen from the government, and that little or no attention was paid to his petition.

Says Charges Were Proved. That after insistent demands and repeated charges, M. E. Myndorff, special agent of the land department, made an investigation in the Evanston district of Wyoming, which substantiated the charges made by Mr. Smith.

That, immediately thereafter, Mr. Myndorff was transferred permanently to Los Angeles.

That the facts again protested and furnished additional facts, and the appeal directly to the secretary of the interior, and that the latter official ordered Commissioner Richards to make an investigation.

That, also, Mr. Smith repeatedly offered to prove his charges, he was notified that a hearing and an investigation by the land commissioner had been made.

That on Dec. 26, 1905, a star chamber investigation was made at Evanston, Wyo., during which only witnesses in the employ of the Union Pacific Coal company were called and were secretly heard.

Rich Patents Issued. That, almost immediately after this hearing, and on the very day the department received a determined protest from Smith, together with substantiating facts, patents were issued to steal lands valued at more than \$1,000,000.

Regarding his attempts to arouse the government to secure its aid in preventing these frauds, Mr. Smith says: "I reluctantly charge the general land office, with all its help, and the government, with failing to keep faith with me, and by a system of procrastination and indifference compelling me to resort to such legal methods as the records of these proceedings disclose."

"I make the bold assertion that there is now in the records of this case at the general land office, an affidavit that carries the aspersion that this arm of the government is controlled by the corporations known as the Union Pacific Railroad company, the Union Pacific Coal company and the Superior Coal company. I do not give much credence to this sworn statement, and only refer to it so that I may be justified in saying that I am the victim of misplaced confidence, and I appeal before the department as an American citizen and ask for recognition."
