

OYSTER SEASON TENSION THROUGH MAY

Angers, Packers and Planters Agree on Recommendation.

BOUNDARY MOVE PROPOSED

May Be Extended Southward in James River. Fish Commission Will Meet Next Week to Consider Abandoning.

Special to The Times-Dispatch.] NEWPORT NEWS, VA., Jan. 18.—Virginia oyster season will be ended until the end of May, if a recommendation of the tongsers, packers and planters goes through.

Request for the extension was made here today as the result of a vote of the James River oyster tongsers by Fish Commissioner Billorey, incoming commissioner, McDonald and committees representing all oysters engaged in the oyster industry.

Changes in Law Discussed

Several questions of legislation calculated to better the oyster industry conserve the natural supply were discussed, but no definite decision reached, the packers' committee from Norfolk being without position.

The James River oyster line may be moved southward and made to extend from Newport News to a point on the opposite side of the river, Commissioner Billorey announced.

Should Conserve Industry

Committees also took the position that the state should be developed conservatively and may recommend all the money derived directly from the oyster industry be used for the oyster industry.

Among the packers who made the trip today are George T. Atwood, of Norfolk, president of the Virginia Oyster Association, and William W. George, of Norfolk.
